The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price growth since September 2006, as well as the annual (point-to-point) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities).

January 2010 Producer Inflation

In January 2010 the Price Index with reference to the base period (September 2006) was 189.04, after recording 188.32 in December 2009. With this, the monthly change rate for January 2010 (i.e., the percentage change in the PPI between December 2009 and January 2010) was 0.68 percent, indicating a 0.05 percentage points higher than that for December 2009 (Table 1).

The respective yearly change (i.e., the percentage change in the PPI between Jan. '09 and Jan. '10) was 25.57 percent, representing a 2.14 percentage

points lower than that for December 2009 (Table 1).

Manufacturing, the most important industrial sub-sector (with 69.75 percent share of all industry), recorded an inflation rate of 28.84 percent.

Mining and Quarrying (with 13.97 percent share of all industry) recorded the highest inflation rate of 41.40 percent. The sub-sector also recorded the highest monthly change rate.

Utilities, (which includes production, transmission and distribution of electricity; collection, purification and distribution of water), recorded 0.66 percent inflation.

Trends

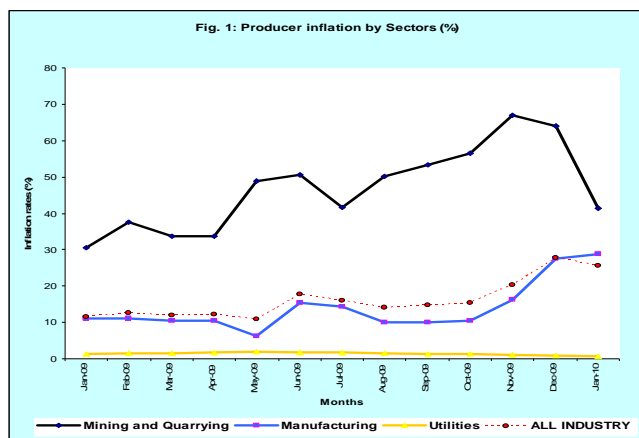
Inflation for January 2010, was higher than the 2009 all industry average, but was smaller than December 2009. The all industry year-on-year inflation had been relatively stable for the first five months of 2009, averaging 11.69 percent.

There was however an upsurge in the rate in June 2009, recording 17.77 percent before declining to

14.12 percent in August 2009. The rate increased thereafter and recorded the highest rate of 27.69 percent for the month of December 2009, representing the highest for the year 2009.

Between January 2009 and January 2010, mining and quarrying sub sector exhibited the highest inflation rates within the year, while the utilities sub sector recorded the lowest inflation rates, below 2 percent (figure 1).

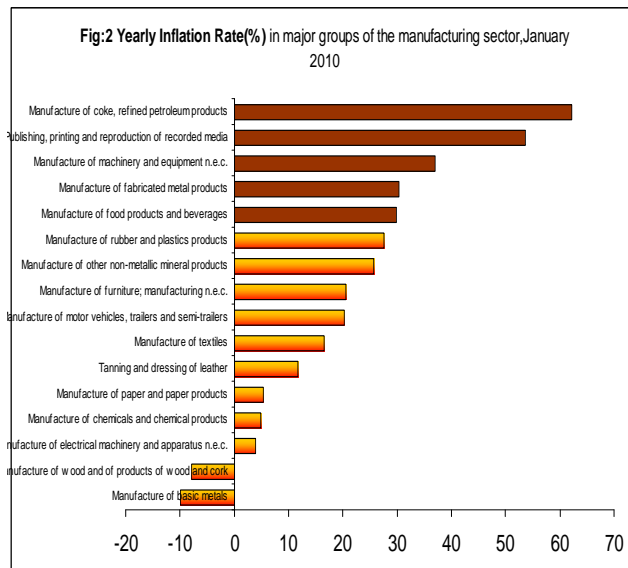
In spite of the higher annual change rates recorded at the end of 2009 (December), the 2009 year average inflation rate (15.33 percent) was about a half of that recorded in 2008 (32.36 percent).



Manufacturing Sector

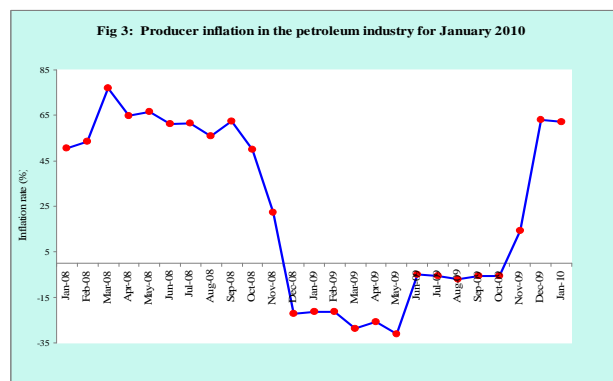
In the manufacturing sector, the producer inflation for 2010 began on high levels, there were very different producer inflation rates among the major groups in this sector for the January 2010.

There was an appreciable inflation rate in manufacture of coke, refined petroleum products whiles Manufacture of wood and of products of wood and cork and Manufacture of basic metals recorded a negative inflation rate of 7.85 percent and 9.84 percent respectively (figure 2).



Petroleum Price Index

Change rates in this group have had a major influence on the manufacturing sector. Between January 2009 and October 2009, producer inflation in this industry recorded a negative rate. It however remained recorded a positive rate thereafter, with the highest rate for the year 2009 being December 2009 (63.04%). The industry recorded a 2009 yearly average producer inflation of -6.67 percent. The rate for January 2010 compared to December 2009 was virtually unchanged (figure 3).

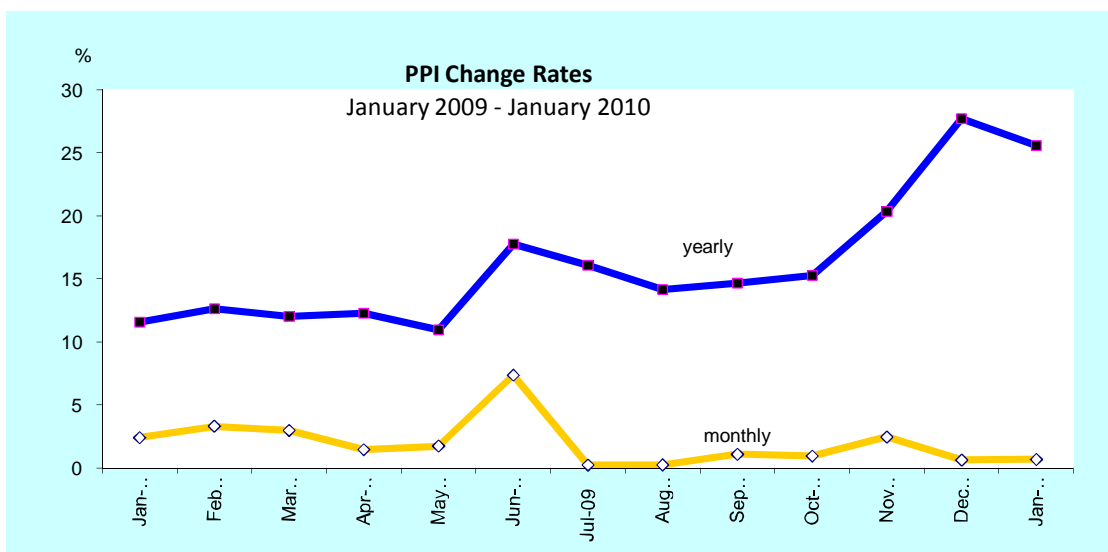
