## Producer Price Inflation Increase to 14.01% in July 2011

### The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price changes since September 2006, as well as the annual (year-on-year) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities) for the last twelve months. The data for the month of June 2011 are provisional, and are subject to revision in the following month. All other data are final.

### July 2011 Producer Inflation

The producer price index increased 14.01 percent between July 2010 and July 2011 (year-on-year), representing an increase in producer inflation of 1.97 percentage points relative to the rate in June 2011 (12.05%). The month-on-month producer prices rose 1.60 percent, after increasing 0.38 percent in the June 2011 (Table 1).

Inflation in mining and quarrying was 34.18 percent, representing an increase in the rate for June 2011 (30.15%) by 4.03 percentage points. Manufacturing which constitutes more than two-thirds of total industry increased to 14.41 percent, from a rate of 11.99 percent in June, 2011. The lowest year-on-year price change of 0.29 was recorded in the Utilities sector.

### Trends

The July 2011 inflation rate was 14.01 percent, representing an increase of 1.97 percentage points relative to the June rate of 12.05 percent, which was the lowest rate in the last 12-month period.

During the 12-month period (July 2010 to July 2011), the all industry recorded the highest producer inflation rate in April 2011 (24.29%). From July 2010 to December 2010, the rate ranged between 15.96 and 18.93 percent. Relatively higher rates between 20.85 and 24.29 percent were

recorded from January to May 2011, before taken a nose dive to 12.05 percent in June 2011. The rate increased in July 2011 (14.01%).

### Manufacturing Sector

Nine out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the manufacturing sector average of 14.41 percent. Manufacture of machinery and equipment n.e.c. recorded the highest inflation rate (48.44%), whilst manufacture of fabricated metal recorded a negative change in the rate (0.63%) (Fig. 2).

### Petroleum Price Index

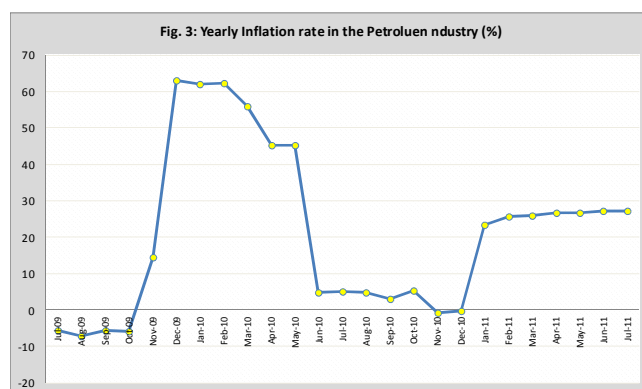
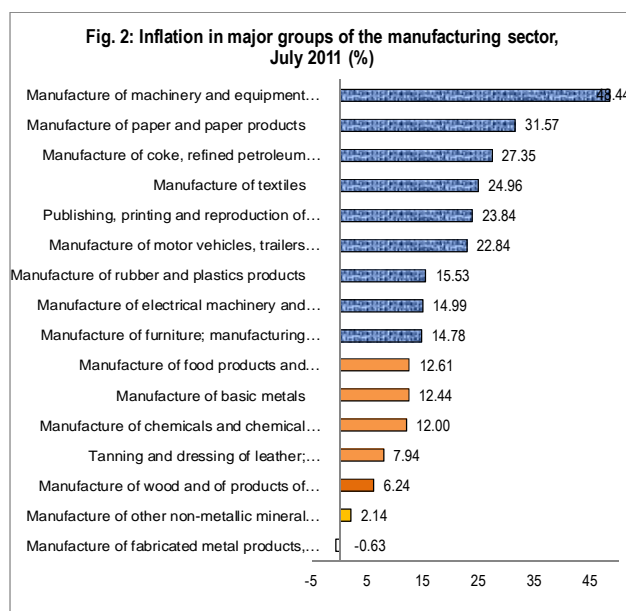
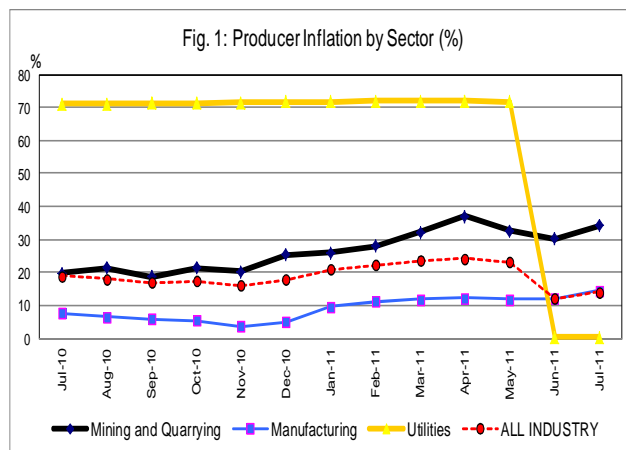
Inflation in this industry stabilized for the first two months of 2010, but dropped between March and June 2010. The rate declined in November 2010 after increasing slightly in October 2010. In January 2011 inflation in the petroleum industry jumped, but has remained stable, recording 27.35% in July 2011 (Fig 3).

### Overview

The year-on-year producer inflation for all industry in July 2011 is 14.01%; the monthly rate is 1.60%.

Mining and quarrying recorded the highest rate of 34.18%, followed by manufacturing (14.41%). Utilities recorded the lowest rate of 0.29%

Manufacturing recorded the highest monthly change of 1.98%; followed by mining and quarrying (1.73%); and utilities (0.01)

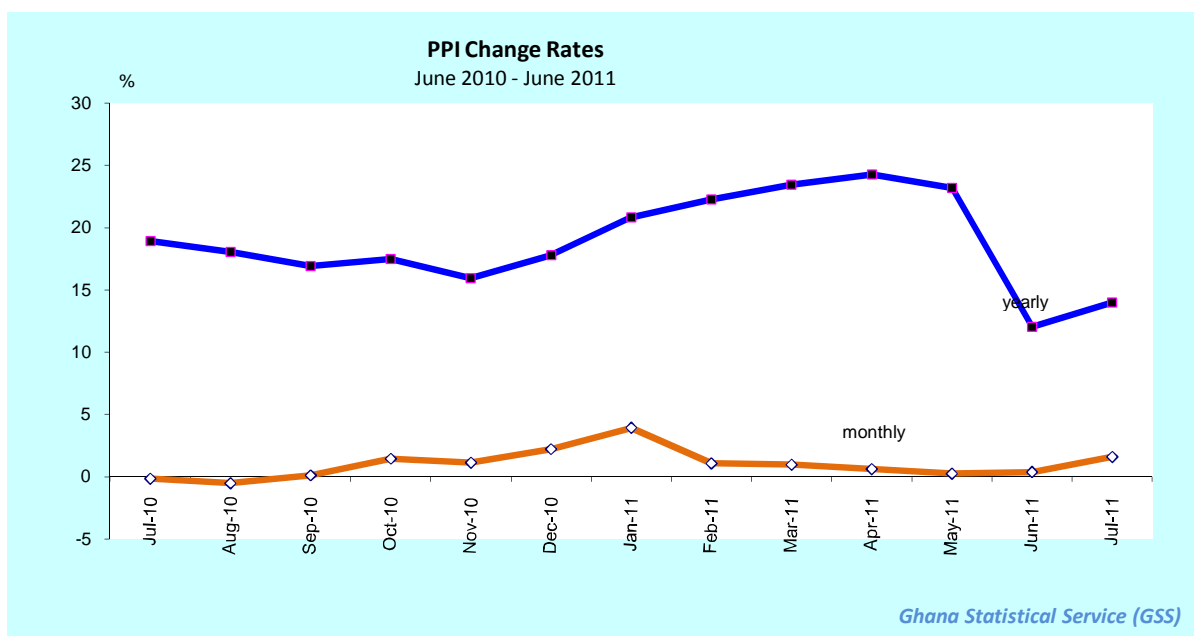
