Producer Price Inflation inches upwards to a rate of 19.42 in June 2010.

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price growth since September 2006, as well as the annual (point-to-point) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities).

June 2010 Producer Inflation

In June 2010 the Price Index with reference to the base period (September 2006) was 212.71, after recording 192.65 in May 2010. This translates to a monthly change rate (i.e., the percentage change in the PPI between May 2010 and June 2010) of **10.41** percent, after 1.02 percent in May 2010 (Table 1).

The respective yearly change (i.e., the percentage change in the PPI between June 2010 and June 2009) was **19.42** percent, indicating a 3.28

percentage points higher than that for May 2010 (Table 1).

Manufacturing, the largest industrial sub-sector (with 69.75 percent share of all industry), recorded an inflation rate of 7.47 percent.

Mining and Quarrying (with 13.97 percent share of all industry) recorded inflation rate of 23.48 percent.

Utilities, (which includes production, transmission and distribution of electricity; collection, purification and distribution of water), recorded inflation rate of 71.30 percent. The sub-sector also recorded the highest monthly change rate (71.38 %).

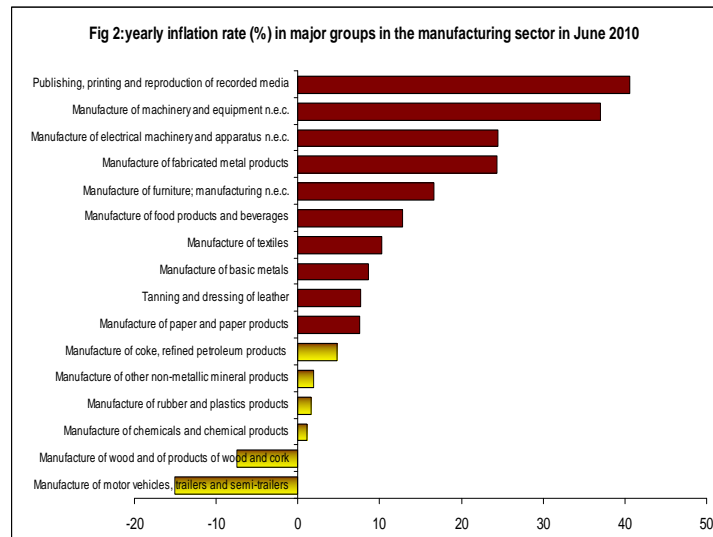
Trends

Inflation for June 2010 was higher than the rate recorded in the same period in 2009 (17.77%). The

all industry year-on-year average inflation for the first half of 2010 was 20.02 percent.

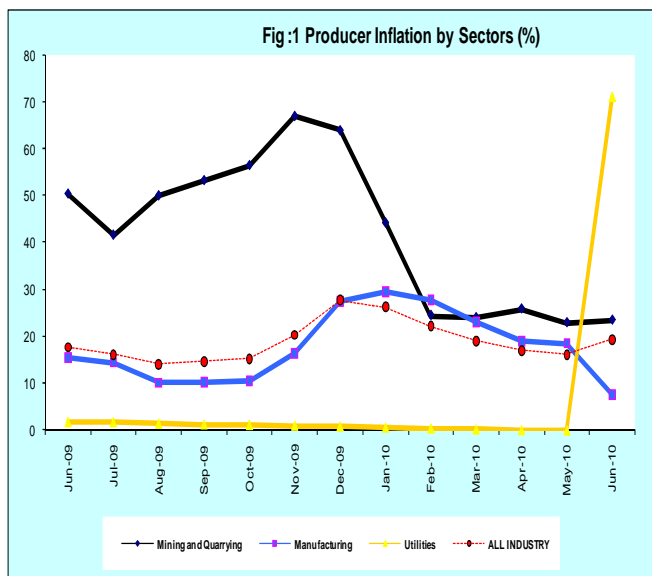
During the 12-month period (June 2009 to June 2010), the all industry recorded the highest inflation rate in December 2009 (27.71 percent). The rates, however, have been declining from January 2010 to May 2010, before it increased in June 2010.

Between June 2009 and June 2010, mining and quarrying sector exhibited the highest inflation rate, except in February 2010 and June 2010, when the manufacturing and utilities sectors respectively recorded the highest (figure 1). The Utilities sector recorded the highest inflation rate (71.30%) in June 2010 after months without perceptible changes in inflation rate.



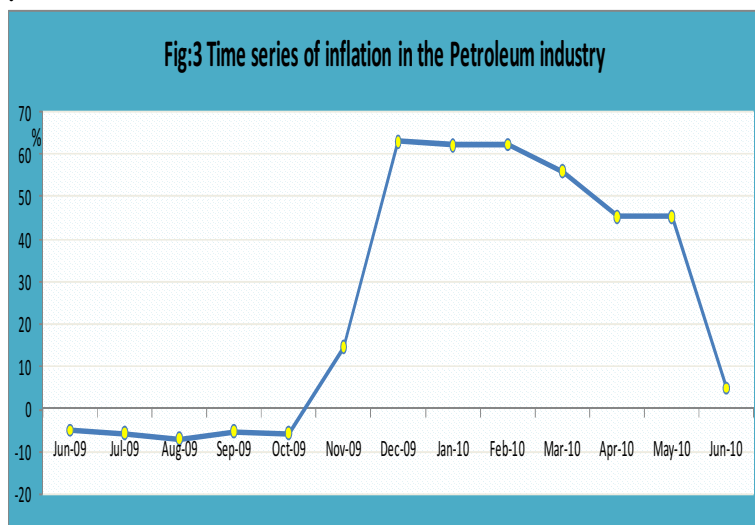
Petroleum Price Index

Between June 2009 and October 2009, producer inflation in the manufacture of petroleum products group recorded a negative rate. It however recorded a positive rate thereafter, with the highest rate for the last 12-month period being December 2009 (63.04%). The industry recorded a 2009 yearly average producer inflation of -6.67 percent. The rate for June 2010 was substantially lower (40.50 percentage points) than that of May 2010 (fig 3).



Manufacturing Sector

Ten out of sixteen groups recorded inflation rates higher than the manufacturing sector average (figure 2). Publishing, printing and reproduction of recorded media recorded the highest inflation rate (40.66%) while manufacture of motor vehicles, trailers and semi-trailers and manufacture of wood and of wood product and cork recorded negative inflation rates of 15.05 and 7.41 percent respectively.

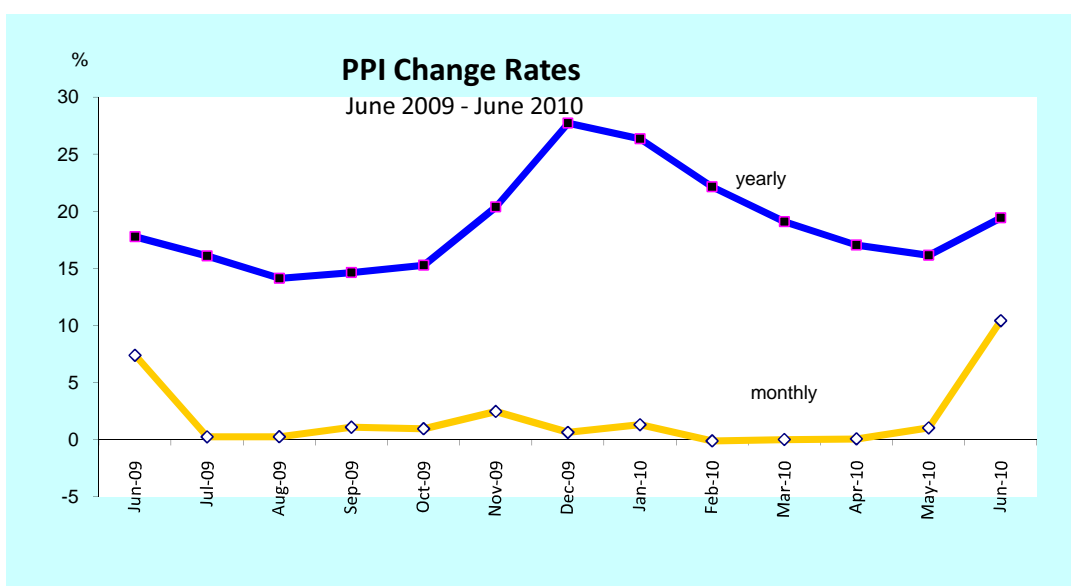
