Producer Price Inflation Increases to 19.59% in September 2011

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price changes since September 2006, as well as the annual (year-on-year) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities) for the last twelve months. The data for the month of September 2011 are provisional, and are subject to revision in the following month, when additional data is available. All other data are final.

September 2011 Producer Inflation

The producer price index increased 19.59 percent between September 2010 and September 2011 (year-on-year), representing an increase in producer inflation of 2.34 percentage points relative to the rate in August 2011 (17.24%). The month-on-month producer prices rose 2.12 percent, after increasing 2.37 percent in August 2011 (Table 1).

Inflation for all industry and the sectors has been on the increase since July 2011. Producer inflation in the mining and quarrying sector was 50.74 percent, representing a 3.81 percentage point increase over the rate for August 2011 (46.93%). Manufacturing which constitutes more than two-thirds of total industry, increased to 16.52 percent, from a rate of 16.31 percent in August 2011. The lowest year-on-year price change of 7.67 was recorded in the Utilities sector (table 2).

Trends

During the 12-month period (September 2010 to September 2011), all industry recorded the highest producer inflation rate in April 2011 (24.29%). From September 2010 to December 2010, the rate ranged between 16.90 and 17.79 percent. Relatively higher rates ranging between 20.85 and 24.29 percent were recorded from January to May 2011. This then declined to 12.05 percent in June 2011,

rising thereafter each month and through September 2011.

Manufacturing Sector

During the month of September 2011, six out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the sector average of 16.52 percent (Fig.2). Manufacture of machinery and equipment n.e.c. recorded the highest inflation rate (48.44%), whilst tanning and dressing of leather and manufacture of hand luggage recorded the only negative rate (- 7.15%).

Petroleum Price Index

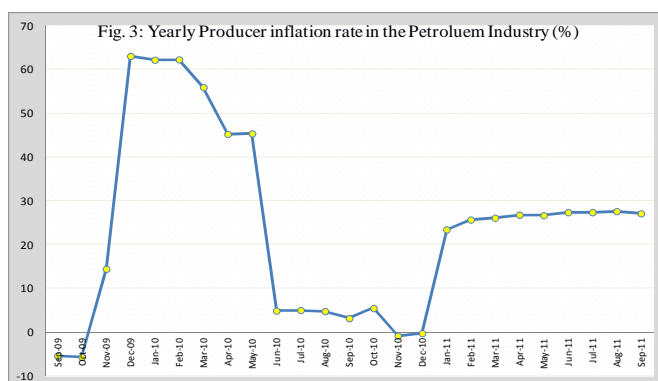
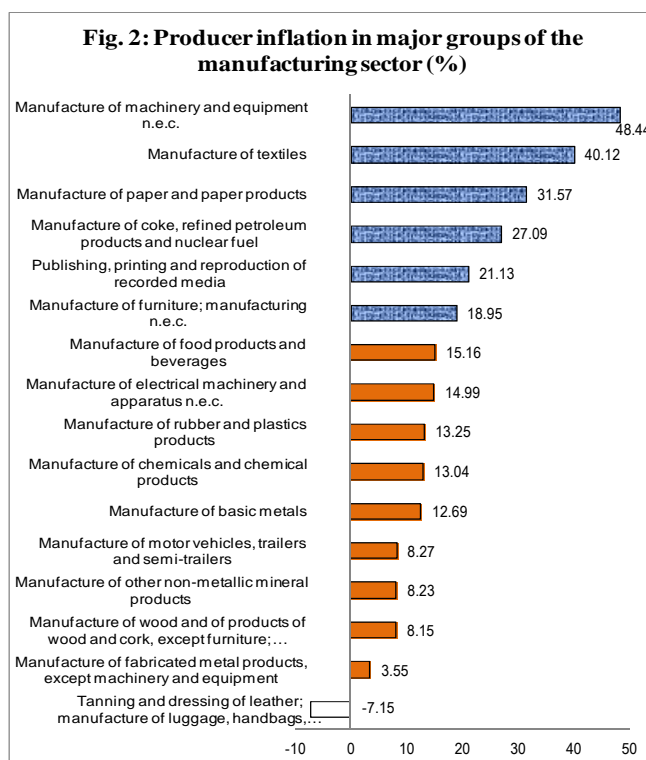
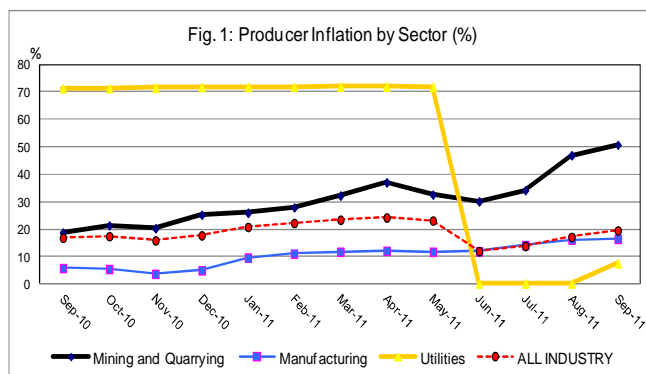
Inflation in this industry subgroup was virtually the same for the first two months of 2010, but dropped between March and May 2010. The rate remained fairly stable between June and September 2010 and declined in November 2010 after increasing slightly in October 2010. In January 2011, inflation in the petroleum industry rose sharply, but has remained stable since (Fig 3).

Highlights

The year-on-year producer inflation for all industry in September 2011 is 19.59%; the monthly rate is 2.12%.

Mining and quarrying recorded the highest year-on-year rate of 50.74%, followed by manufacturing (16.52%). Utilities recorded the lowest rate of 7.67%.

Between August 2011 and September 2011, utilities recorded the highest monthly change of 7.37%, followed by mining and quarrying (3.40%), and manufacturing (0.56%).

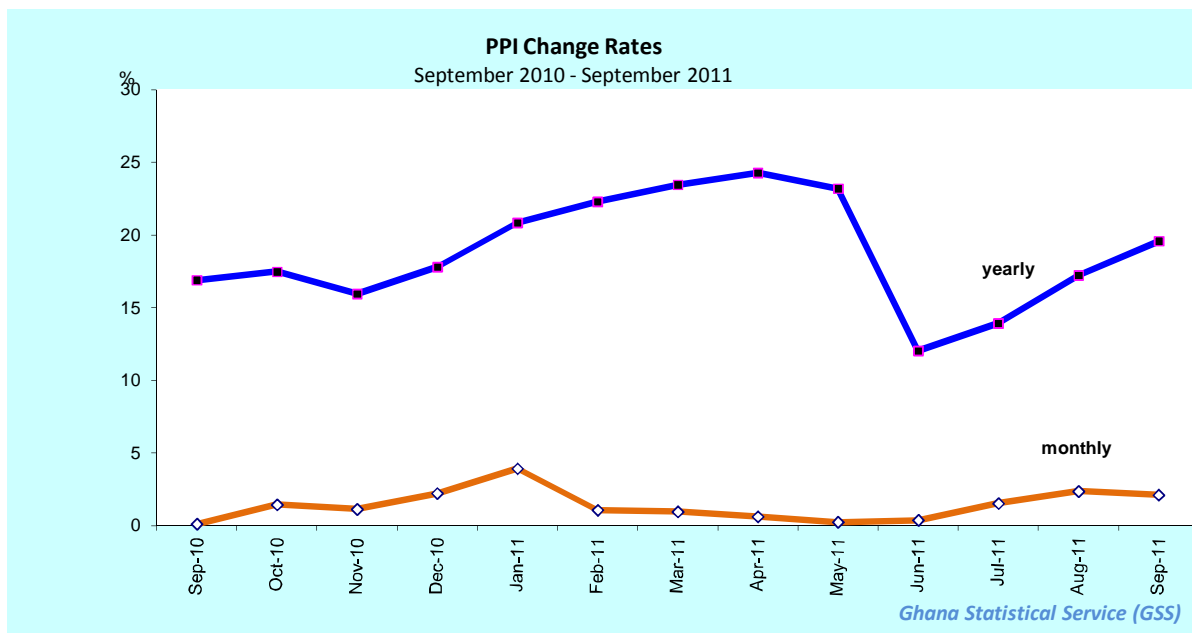
