The GSS now invites sealed tenders from eligible companies for the **Procurement of Android Tablets and Power Banks.** Tendering will be conducted through the International Competitive Tendering (ICT) procedures specified in the Public Procurement Act, 2003 (Act 663), Amendment Act, 2016 (Act914) and in accordance with the guidelines of the Public Procurement Authority of the Republic of Ghana.

- 3. VAT Registration Certificate (Local firms only)
- 4. Company's Registration Certificates (All firms)
- 5. Evidence of Registration with the PPA (Local firms only)
- 6. Two (2) years Audited Financial Statements for the years 2016 & 2017 (All firms)
- 7. Manufacturers' Authorization (if the suppler is not the manufacturer (All firms)
- 8. Letter of Comfort or Evidence of Financial Support from a Reputable Bank (All firms)

Tenders shall be valid for a period of ninety (90) days after the deadline of Tender submission. All bids must be accompanied by a Bid Security of 2% of the Contract price (Bank Guarantee only).

Electronic bidding **will not** be permitted. Late tenders will be rejected. Tenders will be opened in the presence of the tenderers' representatives, who choose to attend at **2.00pm on the** 1st October, 2019.
