GENDER-BASED DOMESTIC VIOLENCE IN GHANA









































FOREWORD

Gender-based domestic violence remains one of the most pervasive threats to women's safety and dignity in Ghana. It affects health, weakens families, limits economic participation, and undermines the country's development goals. The harm is not evenly distributed, where a woman lives shapes her risk, her access to support, and the likelihood that she will be heard.

This brief provides Ghana's most detailed district-level picture of domestic violence, whether physical, sexual, and emotional, using data from the 2022 GDHS, the 2021 Population and Housing Census, and advanced Small Area Estimation techniques. The findings bring a sobering reality into focus: in some districts, nearly half of women aged 15 to 49 have faced physical abuse, and in parts of the Volta, Central, and Savannah regions, sexual and emotional violence affect as many as one in five women. Meanwhile, districts in the Upper West, North East, Bono, and Bono East regions record significantly lower rates, reminding us how uneven risk and protection systems are across the country.

These disparities are a call to action. They point to the influence of local norms, economic stressors, relationship dynamics, and institutional capacity. They also show why national averages can no longer guide policy. If Ghana is to implement the Domestic Violence Act (2007), the National Domestic Violence Policy, and the Affirmative Action Act (2024) effectively, district-specific strategies must become the foundation of prevention and response.

This report offers that foundation. It provides evidence to guide targeted resources, strengthen survivor-centred systems, and build interventions that reflect the realities women face in each district.

Our hope is that government, civil society, traditional authorities, Parliament, development partners, and security agencies use this evidence to accelerate progress toward a Ghana where women and girls live free from fear, harm, and discrimination.

EXECUTIVE SUMMARY

Domestic violence in Ghana remains widespread and deeply unequal across districts. Using Small Area Estimation to merge the 2022 GDHS with the 2021 Population and Housing Census, this brief presents granular estimates of physical, sexual, and emotional violence against women aged 15 to 49.

The findings reveal sharp geographic disparities and underscore the urgency of district-specific interventions.

The key findings are:

- Physical violence is widespread in several regions: Districts in Central, Savannah, and Volta record the highest physical violence rates, reaching 44– 46 percent in many districts. By contrast, districts in Upper West, North East, Bono, and Bono East record the lowest rates, often below 25 percent;
- 2. **Sexual violence hotspots are concentrated in Volta and Savannah**: Sexual domestic violence peaks at 22 percent in Volta, with many districts in Central and Savannah close behind. The North East and Northern regions consistently record the lowest levels, some under 6 percent;
- 3. Emotional violence affects nearly four in ten women in some districts: Savannah, Volta, and Central regions record emotional violence rates between 39 and 46 percent. The lowest rates, around 18–23 percent, are concentrated in Upper West, Western North, and Ashanti;
- 4. Combined abuse is highest in the Volta, Savannah, and Central regions: In Sawla Tuna Kalba, the prevalence of women who have experienced physical, sexual, or emotional violence reaches 61.9 percent, the highest in the country; and
- 5. **District-level variation is substantial:** Even within high-performing or low-performing regions, gaps can be wide. For example, intra-regional disparities in Oti's physical violence are six times higher than in Ahafo. This confirms that district-specific characteristics, not just regional dynamics, shape women's risk.

What this means is that domestic violence in Ghana is not uniform. It follows local patterns driven by social norms, economic stress, relationship dynamics, and access to protection services. High-prevalence districts require tailored prevention, stronger justice systems, and more robust support services. Low-prevalence districts need strategies to sustain progress and prevent resurgence.

Domestic violence is a development issue, a public health issue, and a human rights issue. Targeted, district-specific action is essential to reduce harm, strengthen accountability, and meet Ghana's commitments under SDG 5.

Practical recommendations to address the gender-based violence issues using the data include the following:

- Prioritise high-prevalence districts for intensive interventions: Central, Volta, and Savannah regions, especially districts exceeding 40 percent physical or emotional violence, should receive the highest investment in prevention, protection, and justice services;
- 2. **Strengthen prevention systems**: Use community-driven behaviour-change campaigns, particularly in high-prevalence districts, and partner with traditional and religious leaders to challenge harmful norms;
- 3. **Expand survivor support**: Increase access to safe shelters, psychosocial care, legal aid, and economic empowerment programmes. Ensure services are available in rural high-risk districts;
- 4. **Improve prosecution and accountability**: Strengthen DOVVSU, family courts, and district-level justice systems with training, funding, and dedicated personnel to ensure timely, survivor-sensitive justice;
- 5. **Build coordinated partnerships**: Link government, civil society, security agencies, and development partners to ensure consistent response systems across districts; and
- 6. **Use data for planning and resource allocation**: Integrate district-level SAE estimates into annual district assemblies' plans, budget decisions, and monitoring frameworks.

1. INTRODUCTION

The United Nations (UN) defines domestic violence as a pattern of behavior in any relationship that is used to gain or maintain power and control over an intimate partner. It encompasses physical, sexual, psychological, or economic harm occurring within families, domestic units, or between current or former partners, regardless of shared residence. In Ghana, domestic violence remains a significant public health and human rights challenge, severely affecting women's physical and mental health, economic stability and overall well-being. According to the 2022 UN Women Report, one in four Ghanaian women has experienced sexual or physical abuse from an intimate partner, and nearly 30 percent of women face domestic violence at some point in their lives.

Ghana aligns its efforts with several international frameworks aimed at addressing gender-based violence. One of these is the United Nations Sustainable Development Goals (SDGs), particularly Goal 5, which focuses on achieving gender equality and ending all forms of violence against women and girls. The country also draws guidance from the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) and the African Charter on Human and Peoples' Rights. Additionally, Global campaigns, such as the UN's "16 Days of Activism against Gender-Based Violence," further emphasise the need for and importance of coordinated efforts to tackle gender-based violence.

At the national level, Ghana has demonstrated its commitment to addressing domestic violence through legislative and policy measures. The Domestic Violence Act 2007 (Act 732) and the Affirmative Action (Gender Equality) Act 2024 provide legal protection and support mechanisms for survivors while ensuring the achievement of gender equality in the political, social, economic, educational, and cultural spheres of society. Complementing these laws, the National Domestic Violence Policy offers a strategic framework for preventing and responding to domestic violence.

Despite these efforts, comprehensive and localised data is crucial for effective interventions and monitoring of progress. While the Ghana Demographic and Health Survey (GDHS) 2022 provides valuable national and regional-level data, sub-national variations often remain hidden as it does not fully capture the variation that exists across districts. Small Area Estimation (SAE) techniques address this gap by generating precise and reliable district-level estimates, enabling targeted planning and resource allocation.

This report assesses the prevalence and variability of domestic violence across Ghana's districts, focusing on sexual, physical, and emotional violence experienced by women aged 15 to 49 years. By examining intra and inter-regional disparities, it provides a deeper understanding of localised patterns and informs evidence-based policies and interventions. Addressing domestic violence effectively requires detailed

data on its prevalence and dynamics, ensuring that resources and support systems reach the women and communities most affected.

2. DEFINITION OF CONCEPTS, DATA SOURCES AND ESTIMATION

2.1 Definition of Concepts

2.1.1 Domestic violence

This refers to any act of physical, sexual, psychological, or economic abuse that occurs within a family or domestic unit. It can occur between former or current spouses or partners, regardless of whether they share the same residence or not.

2.1.2 Emotional domestic violence

This is a form of abuse within a domestic or family setting that involves behaviours or actions aimed at causing psychological harm, distress, or emotional suffering to a partner, spouse, or family member. This form of abuse includes verbal abuse, constant criticism, manipulation, threats, humiliation, isolation, and other actions that undermine the victim's self-esteem, sense of security, or emotional well-being.

2.1.3 Physical domestic violence

This is a form of abuse within a domestic or family setting that involves the intentional use of physical force against a partner, spouse, or family member, causing or intending to cause bodily harm, injury, or physical suffering. This includes acts such as hitting, slapping, punching, kicking, choking, burning, or using weapons to inflict harm.

2.1.4 Sexual violence

This is any sexual act, attempt to obtain a sexual act, unwanted sexual comments or advances, or acts to traffic, or otherwise directed against a person's sexuality using coercion, by any person regardless of their relationship to the victim, in any setting

2.1.5 Sexual domestic violence

This is a form of abuse that involves any non-consensual sexual act or behaviour imposed on a partner, spouse, or family member. This includes rape, forced sexual acts, sexual coercion, unwanted sexual advances, or any form of sexual contact that exploits or humiliates the victim. It also encompasses situations where consent is obtained through intimidation, manipulation, or the abuse of power within the relationship.

2.2 Data Sources

The study uses data from the 2022 Ghana Demographic and Health Survey (GDHS), and the 2021 Population and Housing Census (PHC). The study focuses on estimating the prevalence of domestic violence on women 15 to 49 years.

A total of 5,733 women, 15 to 49 years of the GDHS data was used and superimposed on the 2021 PHC data. The domestic violence estimates in this report are from self-reported experiences of individual women within the 12 months prior to the survey or at any point in their lifetime. In the GDHS data, a score was given to a woman based on responses to a set of questions which assessed whether the respondent had experienced specific acts of violence either in the last 12 months or ever in their lifetime.

2.2.1 2.2.1. Computing the interquartile range

The interquartile range (IQR) was used to measure the level of disparity of domestic violence across districts within regions. The interquartile range represents the difference between the medians of the third quartile (also known as the 75th percentile) and first quartile (or the 25th percentile). The larger the interquartile range, the greater the variation in the indicator within the region. The interquartile ranges for each selected domestic violence type in each region were computed to measure the extent to which district estimate deviates from the regional estimate.

2.3 Estimation

This approach of small area adopts the UNFPA methods that assumes a dichotomous outcome variable which can only be found in the survey data. A logit model was developed by ensuring that the predictors of the outcome variable (Domestic violence) can be found both in the auxiliary data (census) and in the survey data (2022 GDHS)

The small area estimation approach helped to estimate reliable and efficient estimates of indicators at the district level which otherwise would not have been possible using the direct estimation approach. This methodological guide provided details on measurement of domestic violence for women aged 15-49 years using 2022 GDHS data. The predictive strength of the model for the two indicators passed the 70 percent mark and the census estimates for the indicators within the confidence interval of the DHS estimates at the district level.

3. JUSTIFICATION FOR THE SELECTION OF KCORRELATES

3.1 Sex

The sex of the individual is fundamental to understanding domestic violence, as women are disproportionately affected by intimate partner violence. Including sex as a variable helps to highlight these disparities and understand the broader context of gender-based violence.

3.2 Type of Locality

The geographical location (urban or rural) can significantly impact the prevalence and perception of domestic violence. Rural areas may have less access to support services, while urban areas may have different social norms and structures that influence domestic violence dynamics.

3.3 Education

The educational level of both the woman and her partner can influence vulnerability to domestic violence. Higher education levels are often associated with increased awareness of rights and access to resources, potentially reducing the likelihood of experiencing violence.

3.4 Marital Status

Marital status (married, single, divorced, or widowed) is a key predictor, as married women may experience different dynamics of power and control compared to those in non-marital relationships. Understanding marital status can provide insights into the context of domestic violence.

3.5 Religion

Religious beliefs can shape attitudes toward domestic violence, influencing both the victim's and the perpetrator's behavior. Different religions may promote varying levels of tolerance for domestic violence, making this a relevant variable.

3.6 Occupation of Partner

The occupation of the partner can provide insights into economic stability, power dynamics, and potential stressors that may contribute to domestic violence. Certain occupations may be associated with higher levels of stress or socioeconomic instability, which can influence relationship dynamics.

3.7 Occupation of Woman

A woman's occupation can impact her economic independence and decision-making power within a relationship. Employed women may have more resources to leave abusive situations, while unemployment can increase vulnerability to violence.

3.8 Number of Children ever Born

The number of children can influence the dynamics of domestic violence, as women with more children may feel trapped in abusive relationships due to financial dependence or concerns about child welfare. Additionally, parenting stress can be a factor in domestic violence.

4. KEY FINDINGS

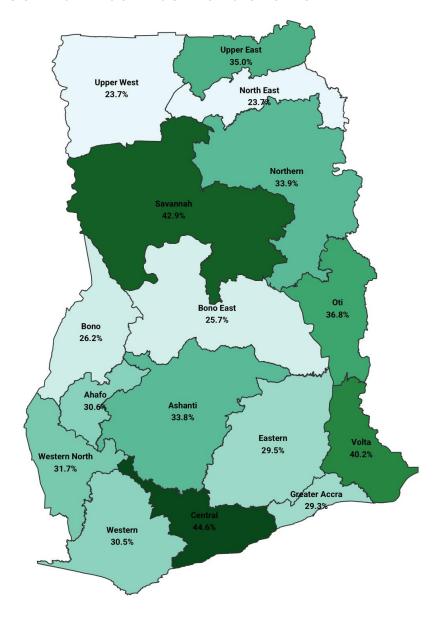
4.1 Physical Domestic Violence

This section provides key highlights of district-level estimates on physical domestic violence across the three analysed domains. It includes estimates for each district and examines both intra-and inter-regional disparities in experiences of physical domestic violence.

Central Region recorded the highest rate of physical domestic violence at 44.6 percent, followed by the Savannah Region (42.9%) and Volta Region (40.2%).

Upper West and North East regions recorded the lowest rate at 23.7 percent respectively.

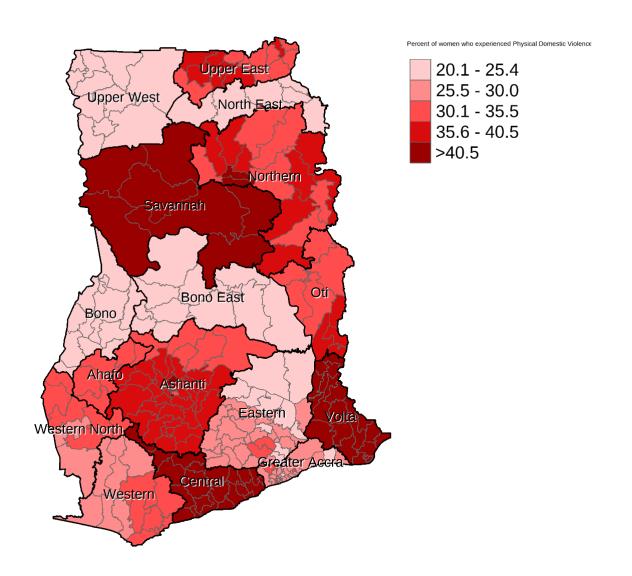
FIGURE 4.1: REGIONAL ESTIMATES OF PHYSICAL DOMESTIC VIOLENCE



Physical domestic violence is most pronounced among women in districts across Central, Volta, and Savannah Regions, with four in every 10 women with an experience.

In all districts in the Upper West, North East, Bono and Bono East regions, onequarter or fewer (20.0 to 25.0%) have experienced physical domestic violence

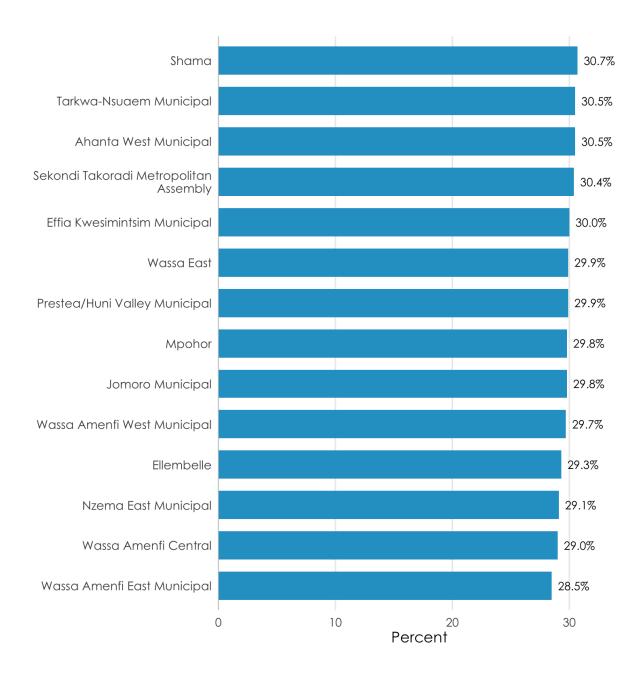
FIGURE 4.2: DISTRICT DISTRIBUTION OF PHYSICAL DOMESTIC VIOLENCE



Physical domestic violence prevalence in the Western Region was highest in Shama (30.7%), followed by Tarkwa-Nsuaem Municipal and Ahanta West Municipal at 30.5 percent each, with about three in ten respondents reporting such violence.

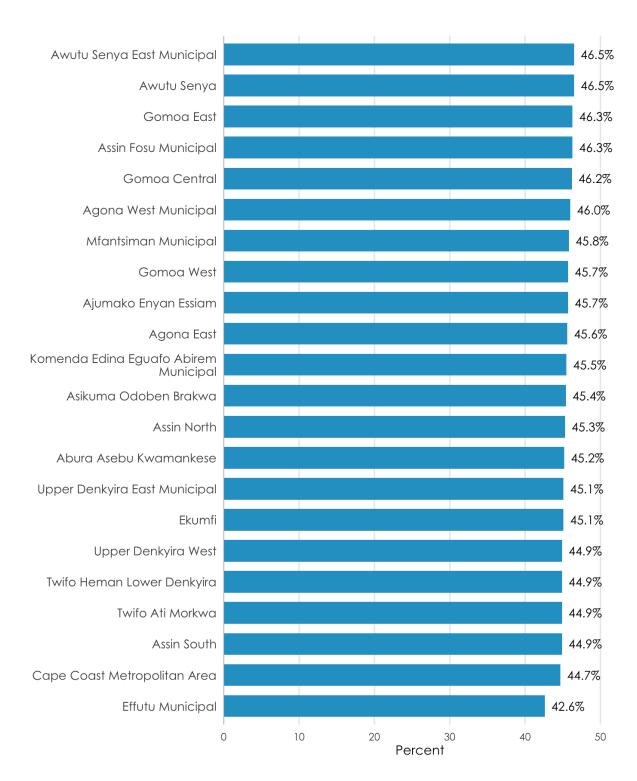
Lowest prevalence was in Nzema East Municipal (29.1%), Wassa Amenfi Central (29.0%) and Wassa Amenfi East Municipal (28.5%).

Nearly one in two respondents reported experiencing physical violence in Awutu Senya East and Awutu Senya at 46.5 percent respectively and Gomoa East (46.3%). The lowest prevalence were in Effutu Municipal (42.6%), Cape Coast Metropolitan Area (44.7%), and Assin South (44.9%).

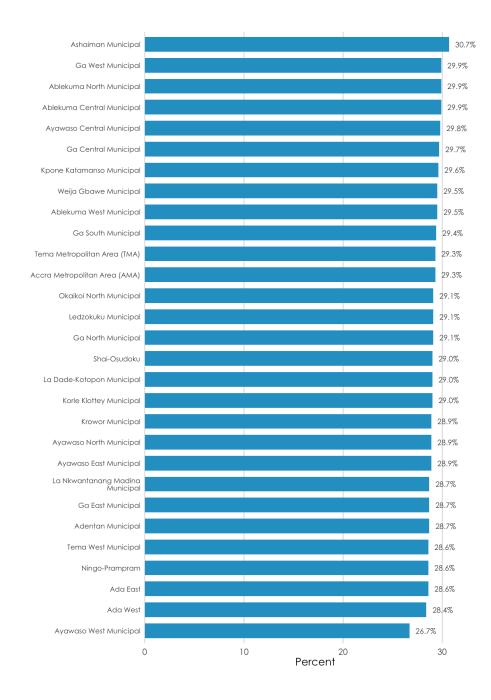
FIGURE 4.4: DISTRICT-LEVEL ESTIMATES OF PHYSICAL DOMESTIC VIOLENCE IN THE CENTRAL REGION



Prevalence of physical domestic violence in the Greater Accra Region was highest in Ashaiman Municipal (30.7%), Ga West Municipal (29.9%), and Ablekuma North Municipal (29.9%), with about three in ten respondents reporting such violence.

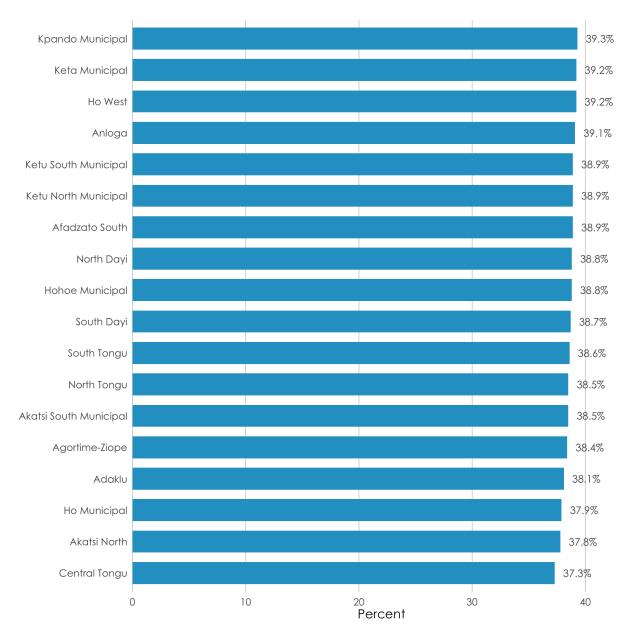
Lowest prevalence was in Ayawaso West Municipal (26.7%), Ada West (28.4%), and Ada East (28.6%).

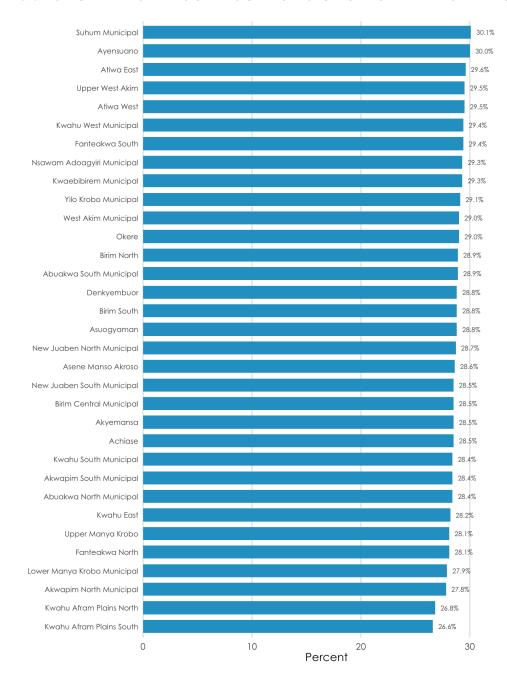
Nearly four in ten women in the Volta Region experienced physical domestic violence with Kpando Municipal (39.3%) recording the highest and and Ho Municipal (37.9%) the lowest

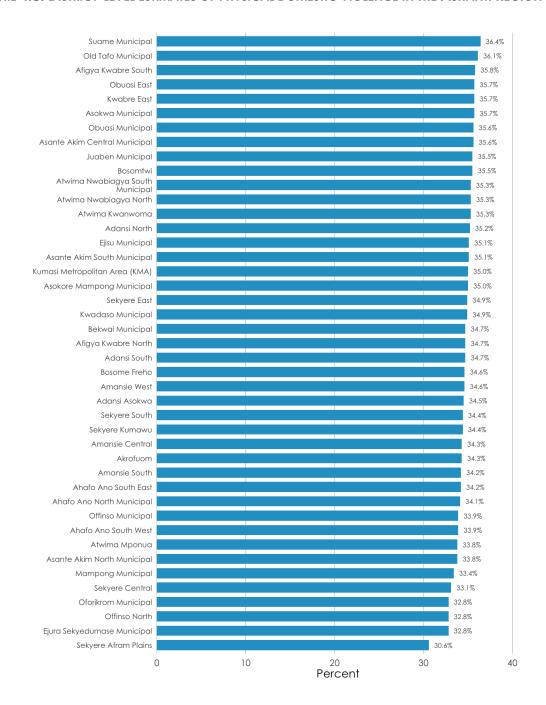
About three in ten women reported experiencing physical domestic violence in Suhum Municipal (30.1%), Ayensuano (30.0%), and Atiwa East (29.6%), while the lowest prevalence was recorded in Kwahu Afram Plains South (26.6%).

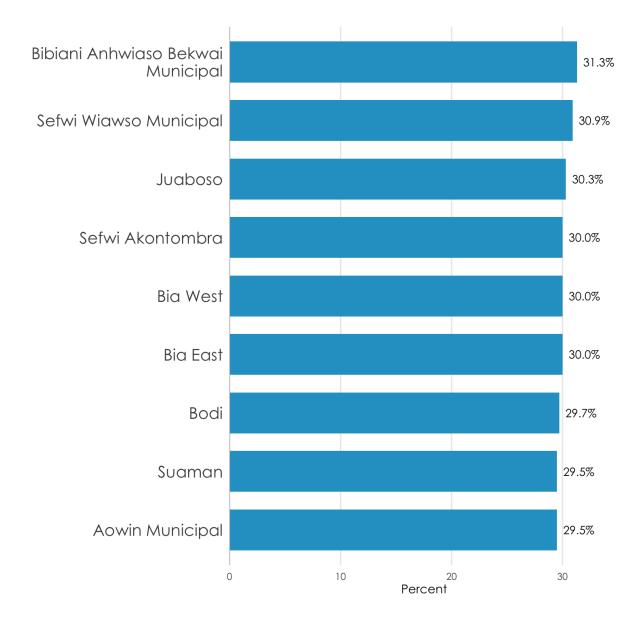
Over one-third of women reported physical violence, with the highest rates in Suame Municipal (36.4%), Old Tafo Municipal (36.1%), and Afrigya Kwabre South (35.8%) while lower rates were recorded in Sekyere Afram Plains (30.6%), Ejura Sekyedumase Municipal (32.8%), and Offinso North (32.8%).

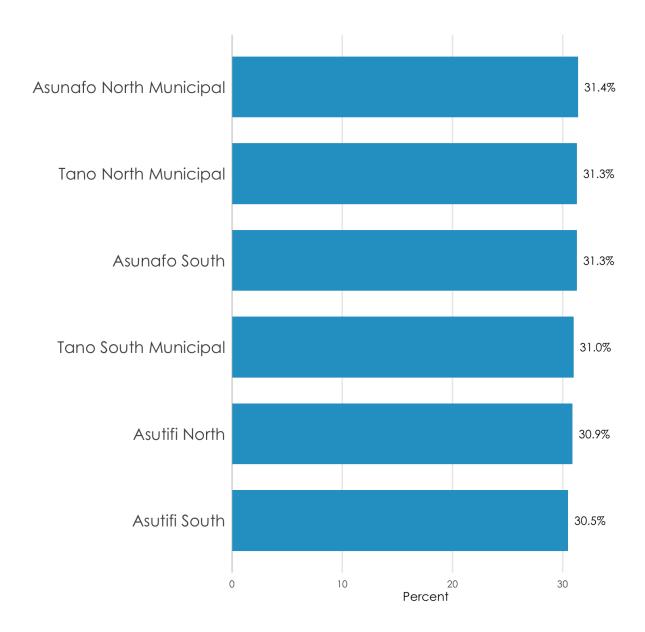
Less than a third of women in the Western North Region have experienced physical sexual violence, with Bibiani Anhwiaso Bekwai Municipal recording the highest rate at 31.3 percent and Bodi the lowest at 29.7 percent.

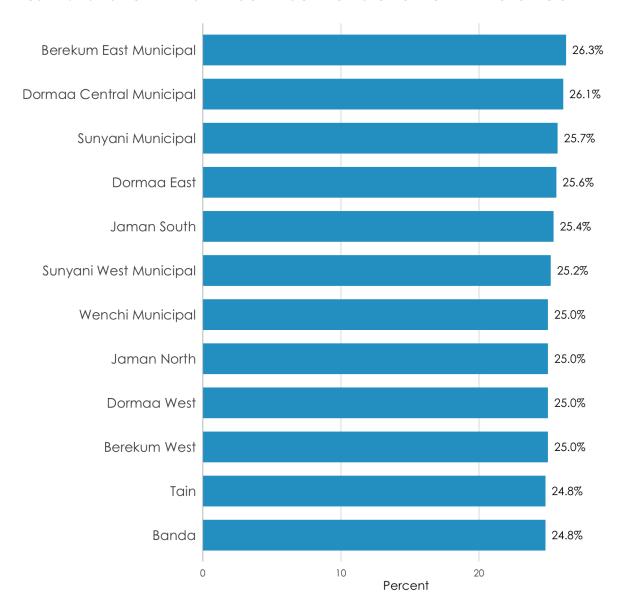

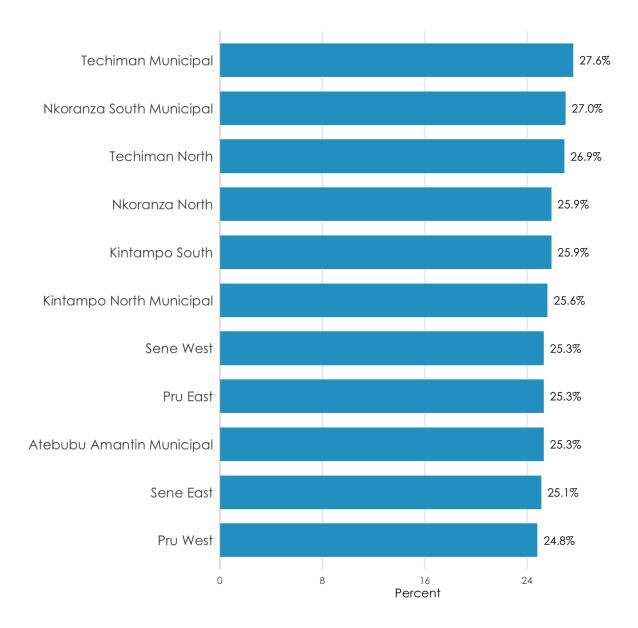

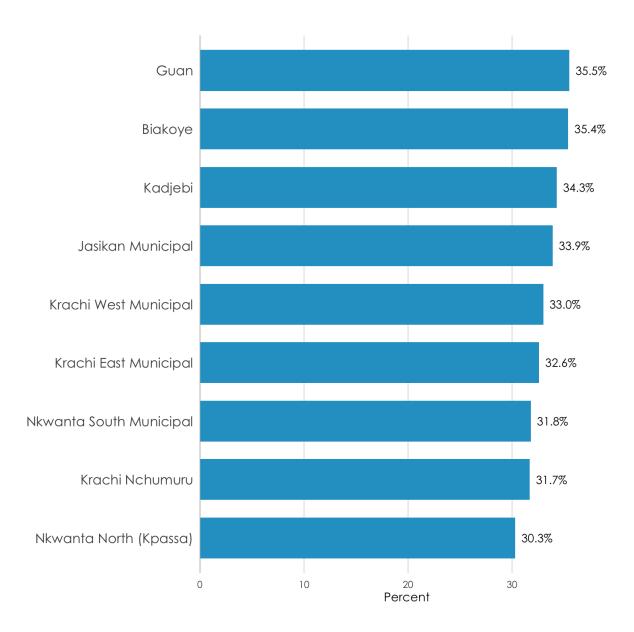

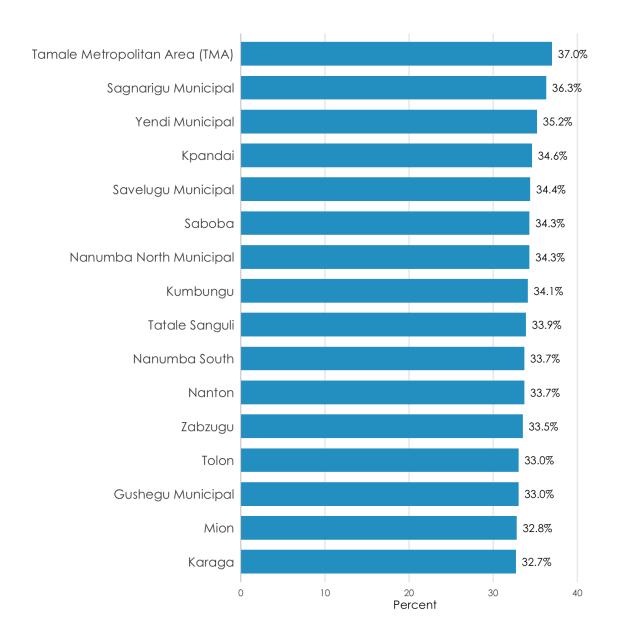

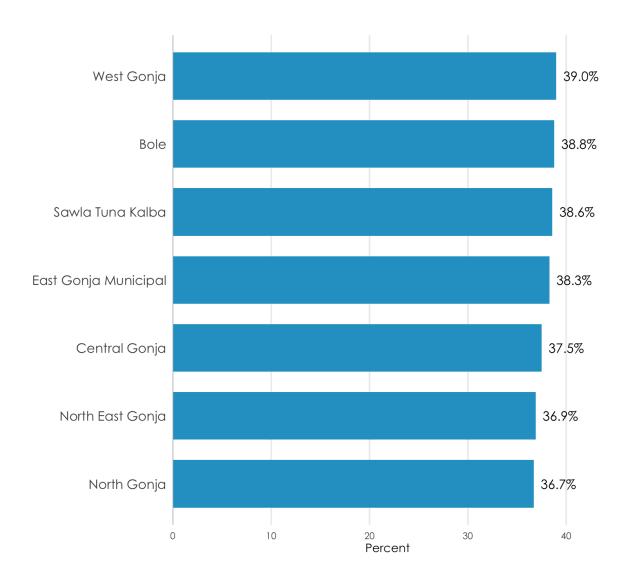

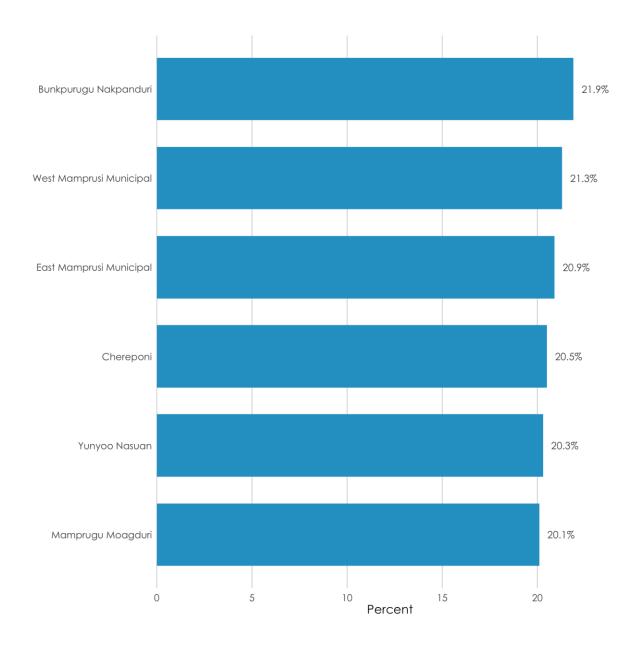

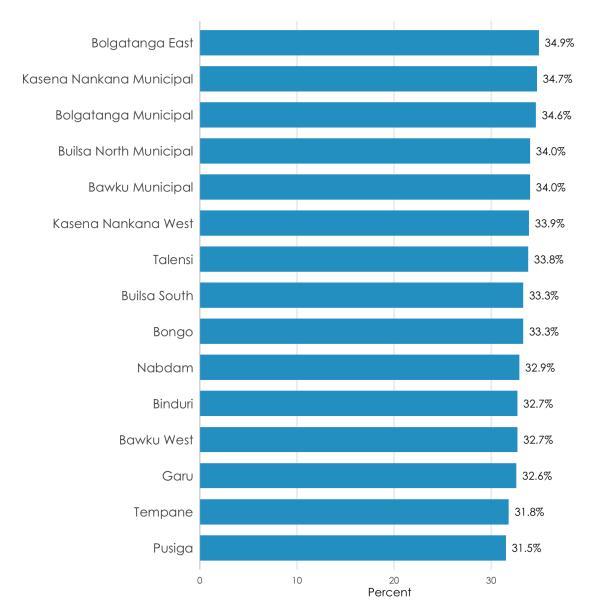

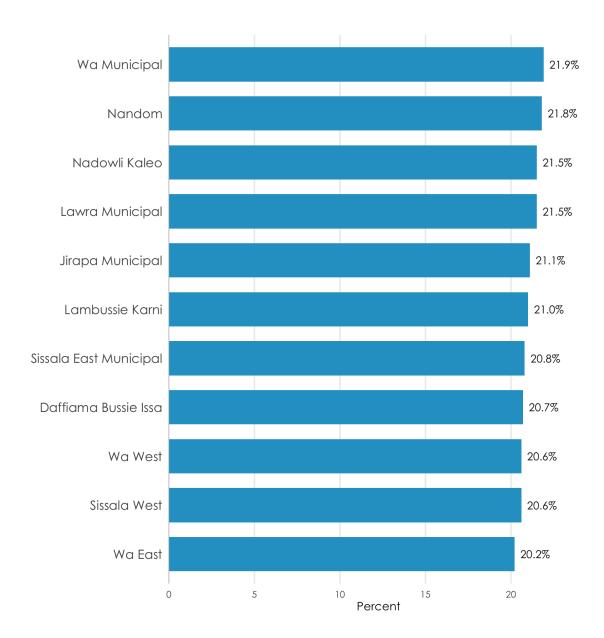

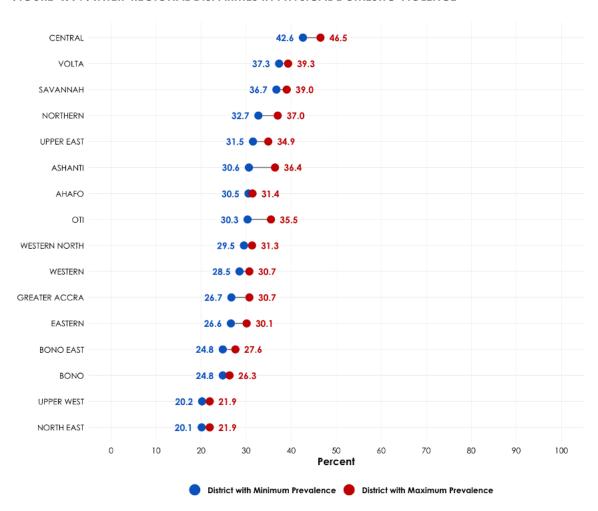

FIGURE 4.19: INTER-REGIONAL DISPARITIES IN PHYSICAL DOMESTIC VIOLENCE

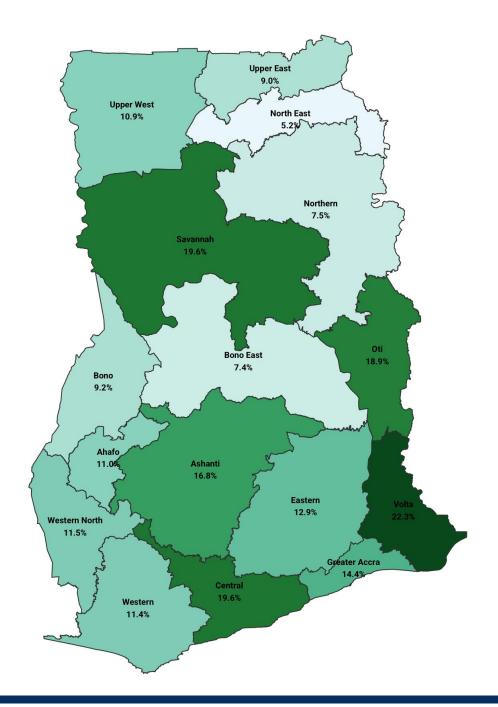

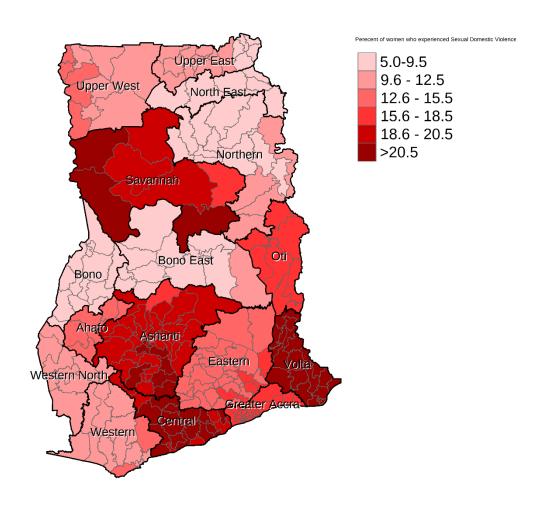
FIGURE 4.20: REGIONAL ESTIMATES OF SEXUAL DOMESTIC VIOLENCE

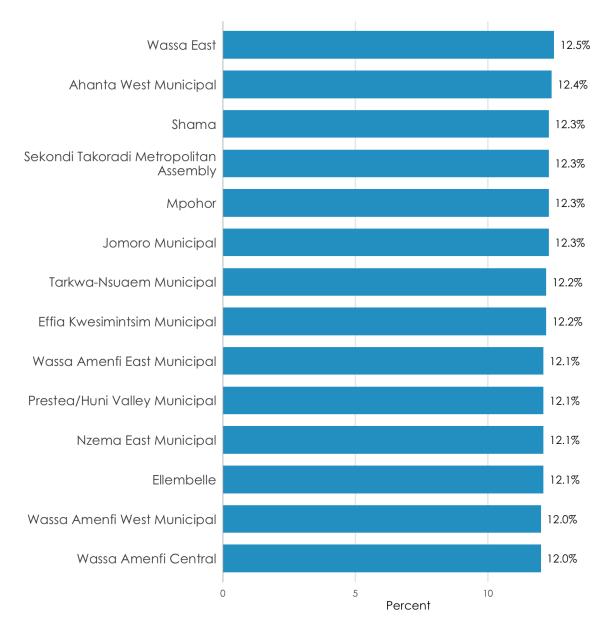

FIGURE 4.21: DISTRICT ESTIMATES OF SEXUAL DOMESTIC VIOLENCE



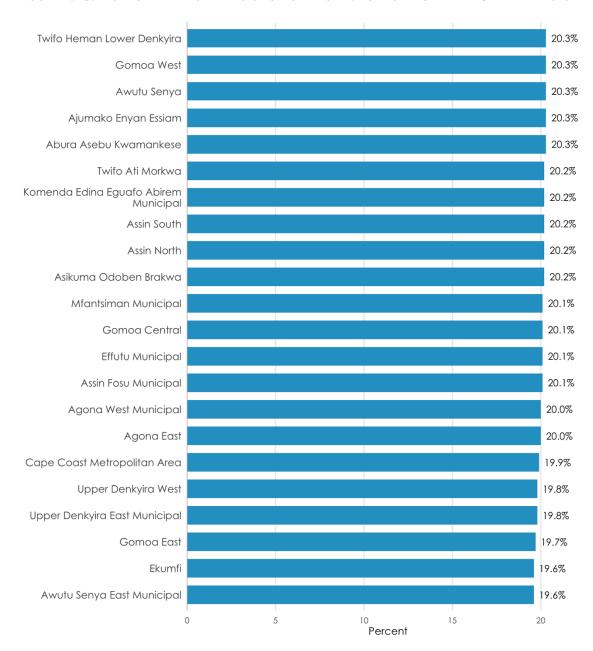

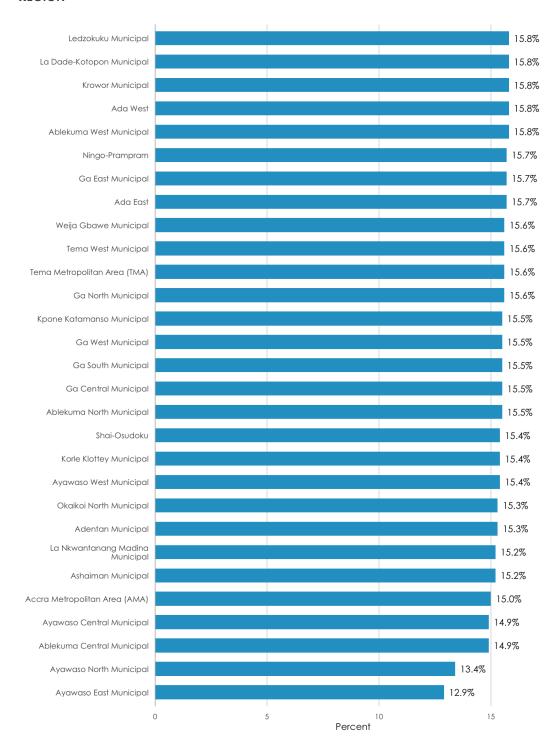

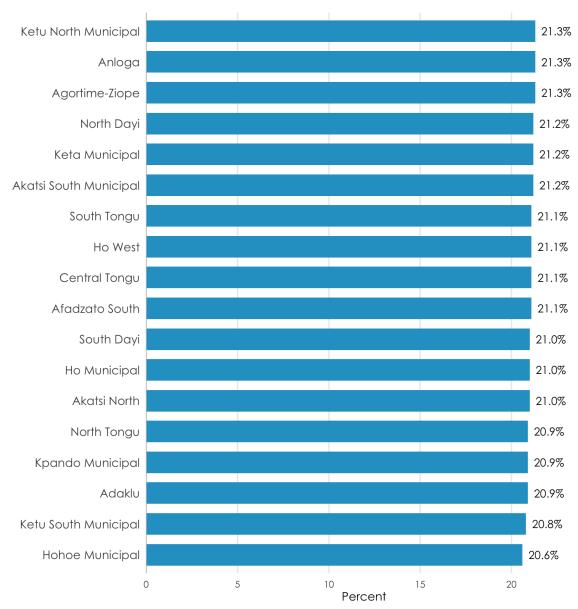
FIGURE 4.24: DISTRICT-LEVEL ESTIMATES OF SEXUAL DOMESTIC VIOLENCE IN THE GREATER ACCRA REGION

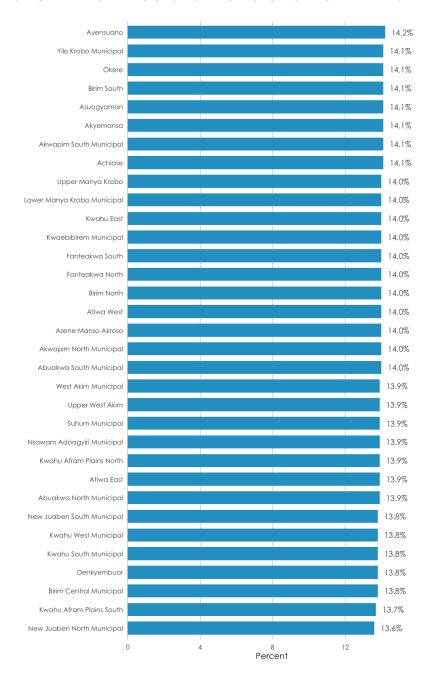

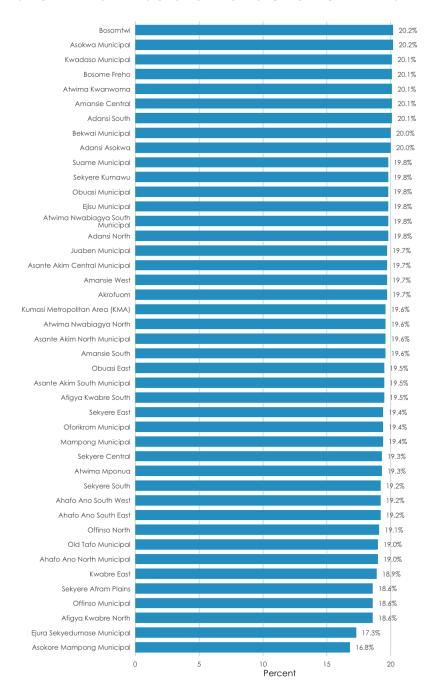
FIGURE 4.26: DISTRICT-LEVEL ESTIMATES OF SEXUAL DOMESTIC VIOLENCE IN THE EASTERN REGION

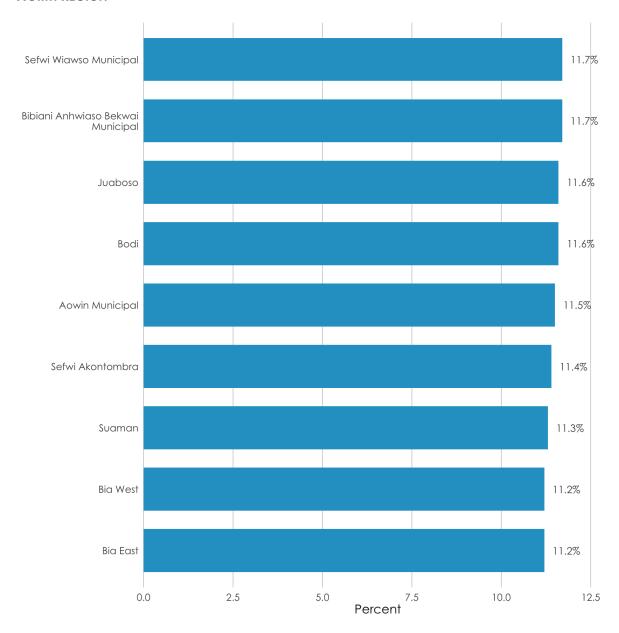

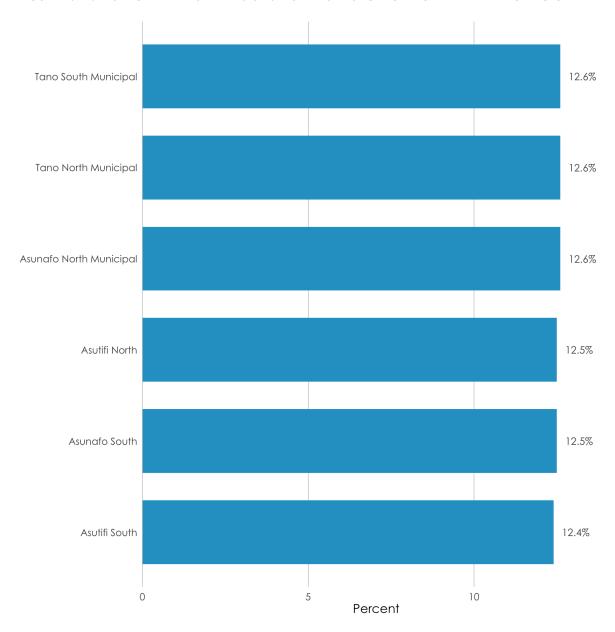

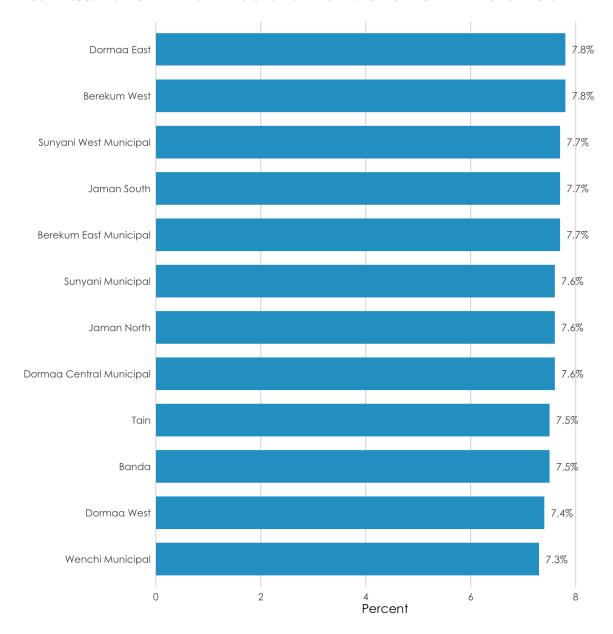

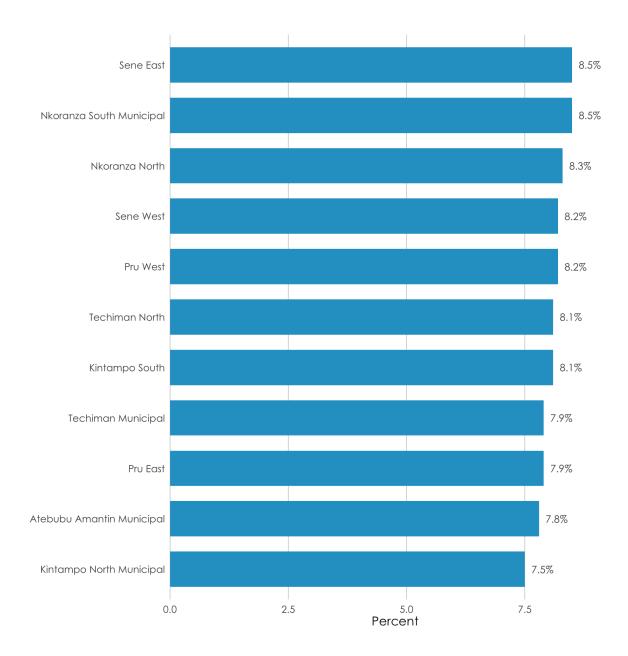

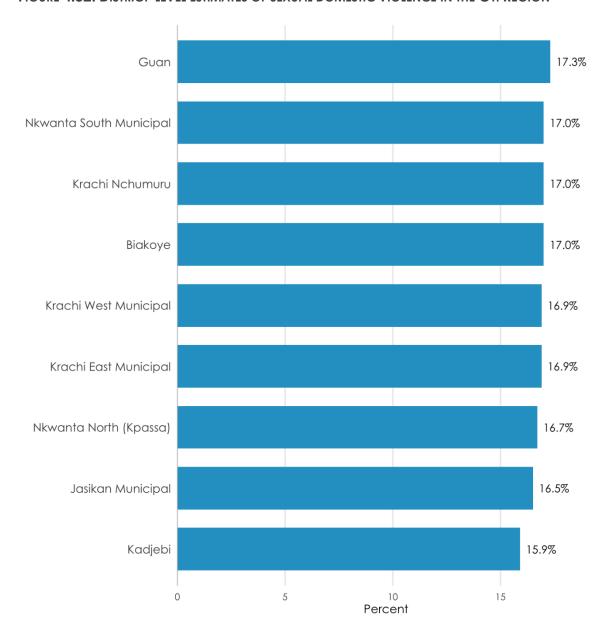

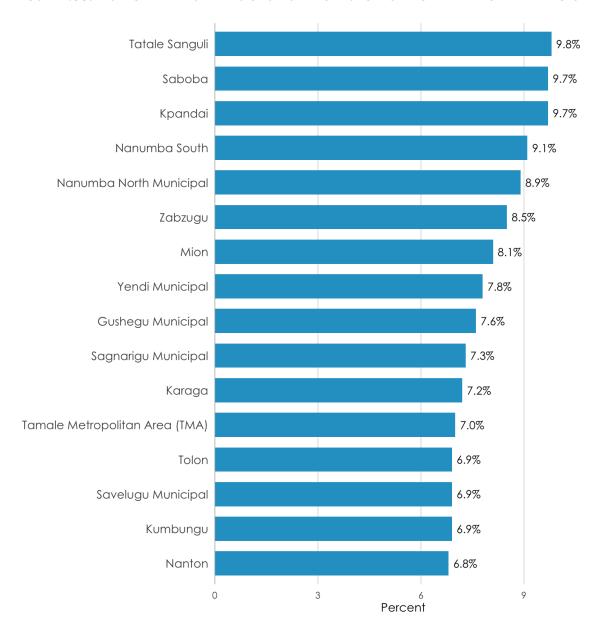

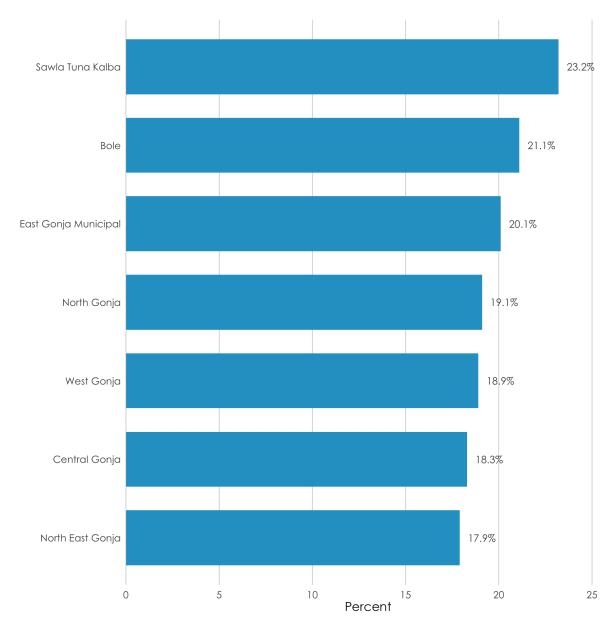

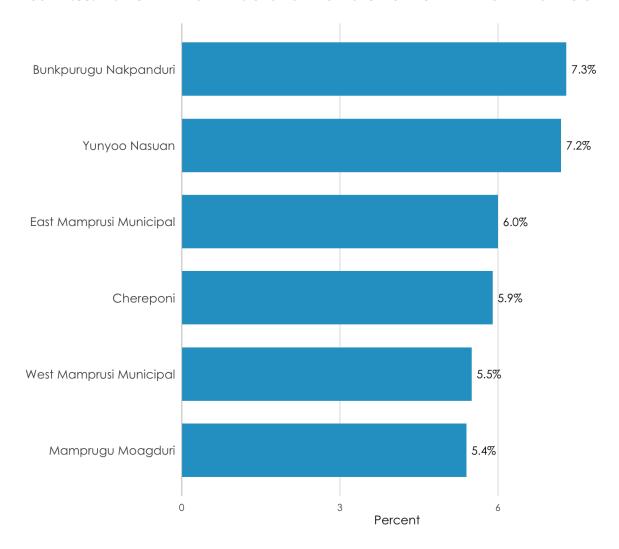

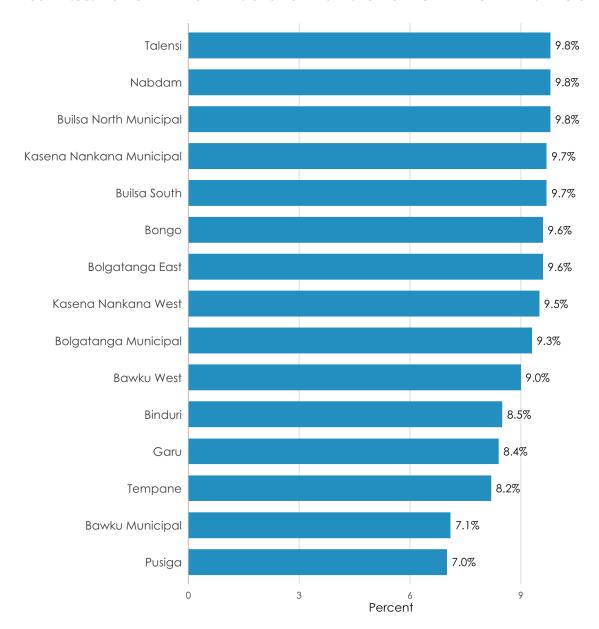

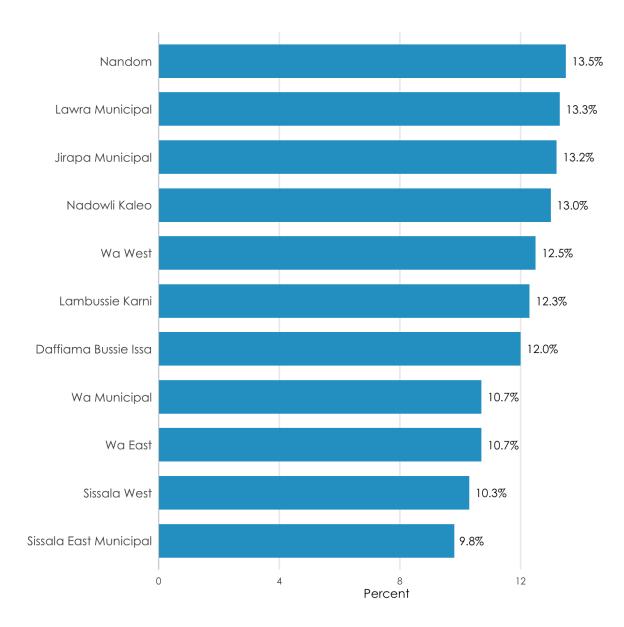

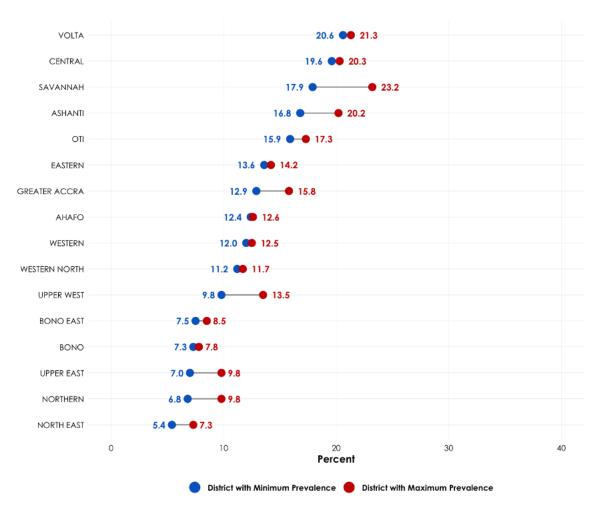

FIGURE 4.38: INTRA-REGIONAL DISPARITIES IN SEXUAL DOMESTIC VIOLENCE



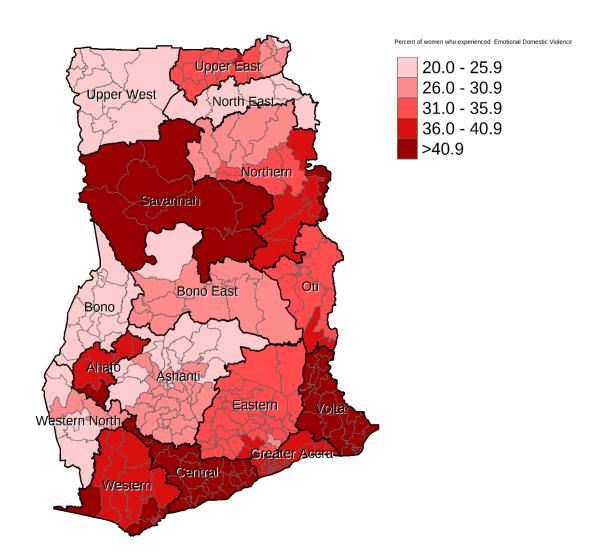

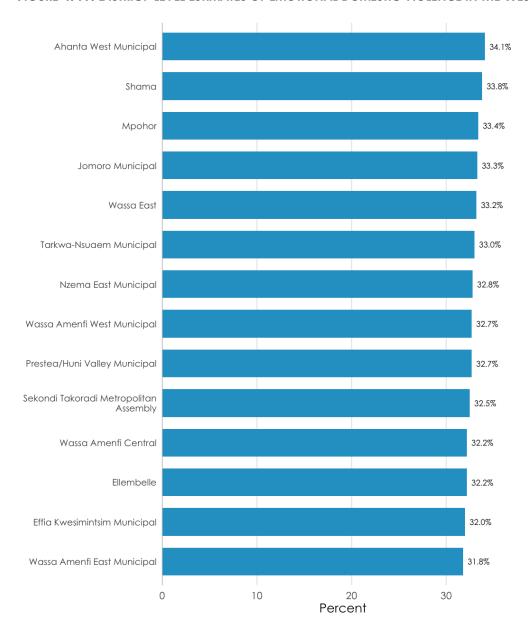

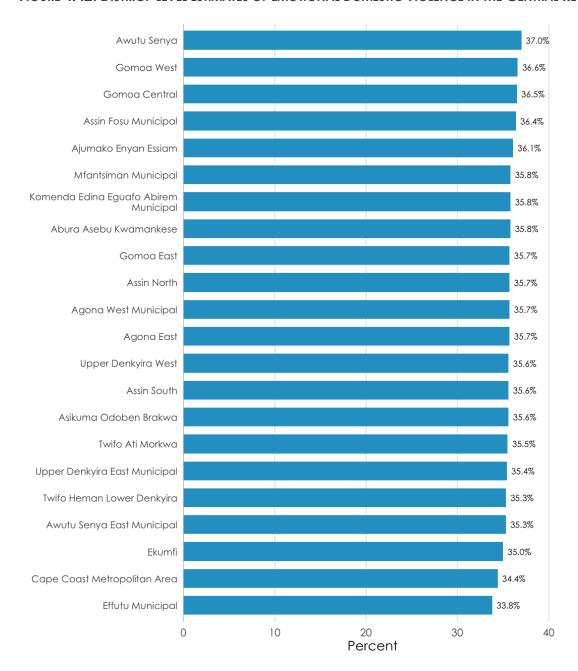

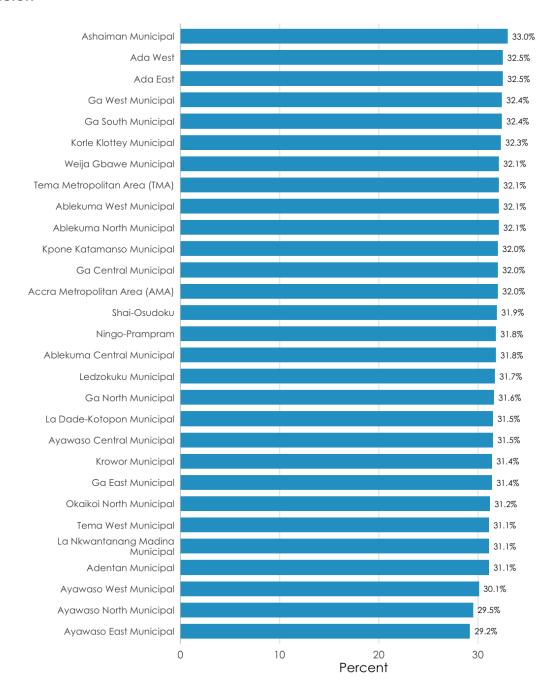

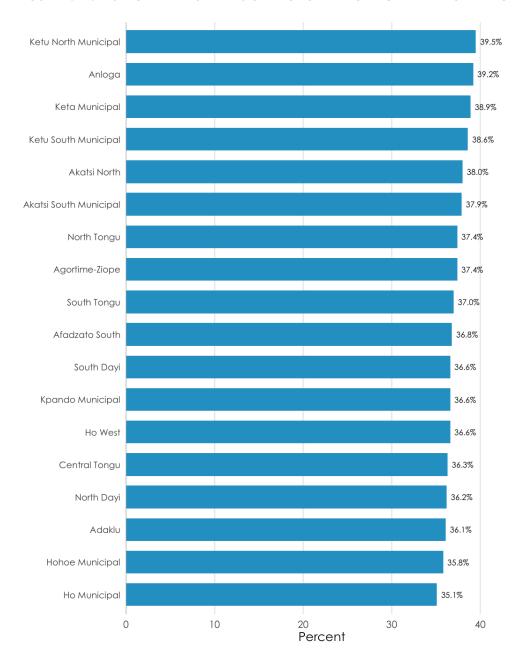

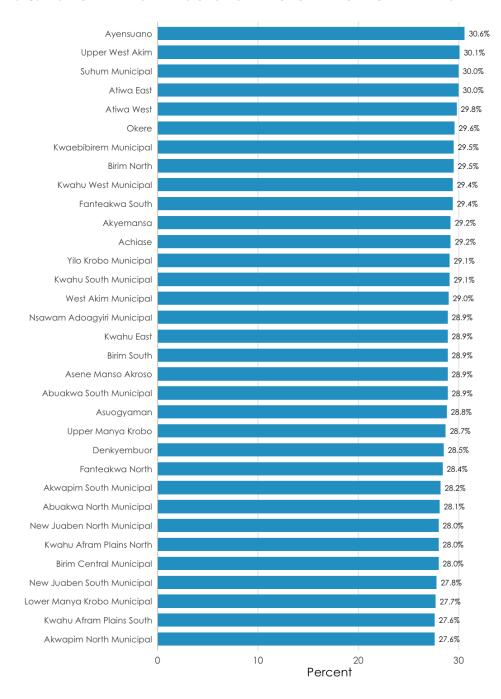

FIGURE 4.44: DISTRICT-LEVEL ESTIMATES OF EMOTIONAL VIOLENCE IN THE VOLTA REGION



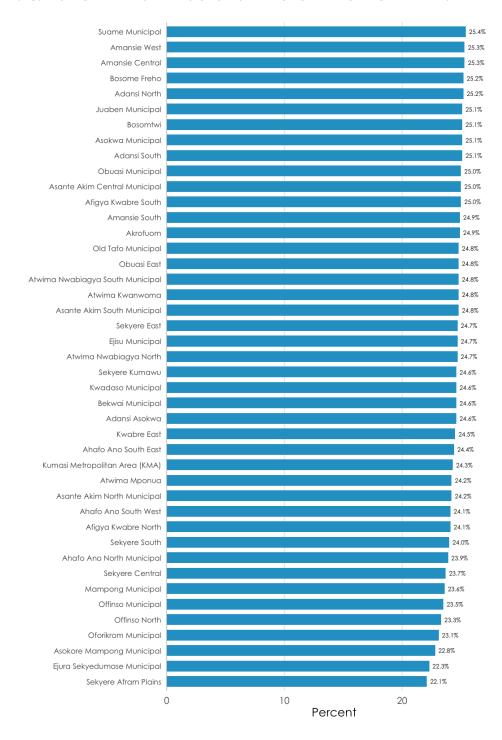

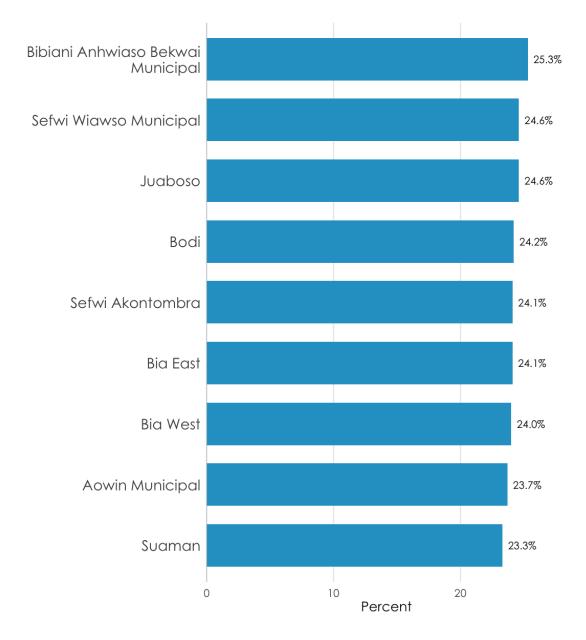

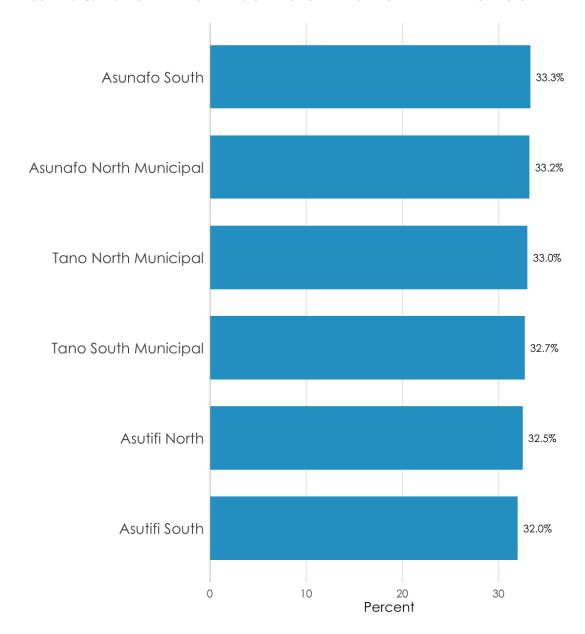

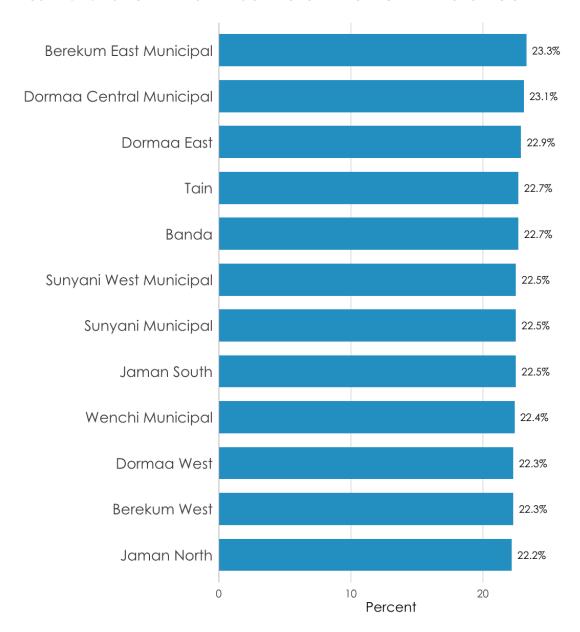

FIGURE 4.48: DISTRICT-LEVEL ESTIMATES OF EMOTIONAL VIOLENCE IN THE AHAFO REGION



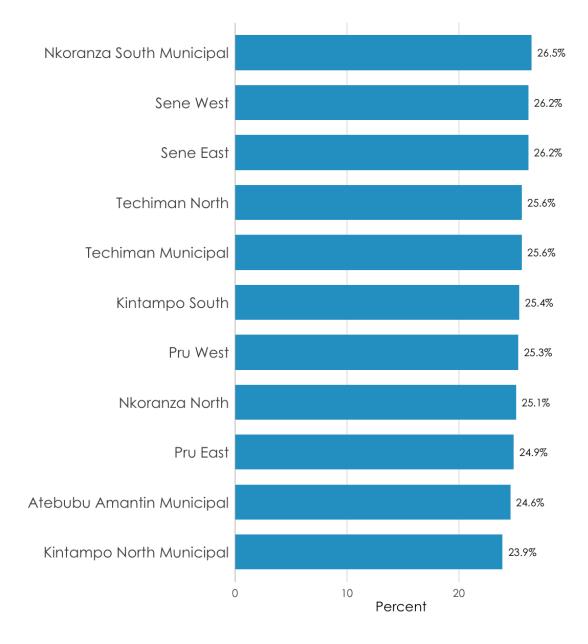

FIGURE 4.49: DISTRICT-LEVEL ESTIMATES OF EMOTIONAL VIOLENCE IN THE BONO REGION



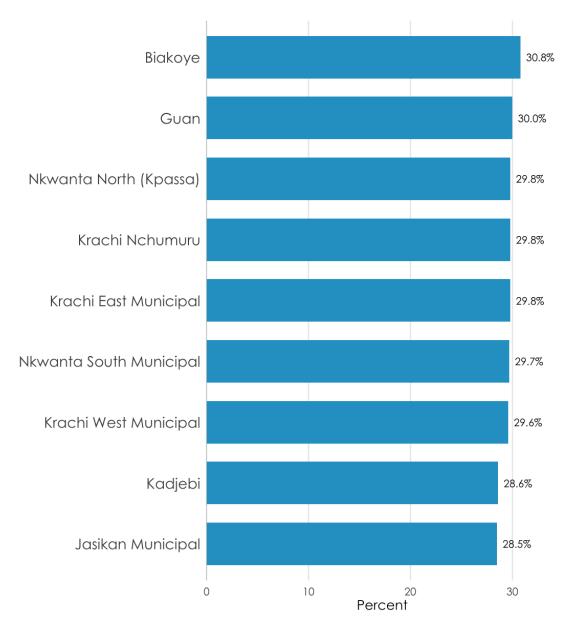

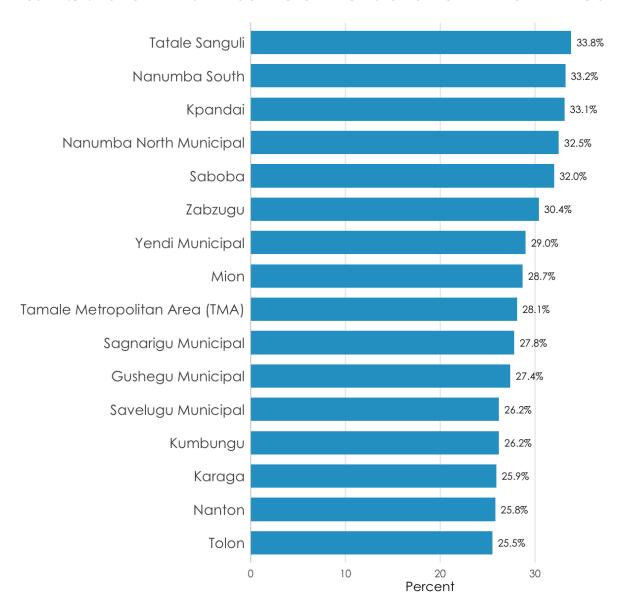

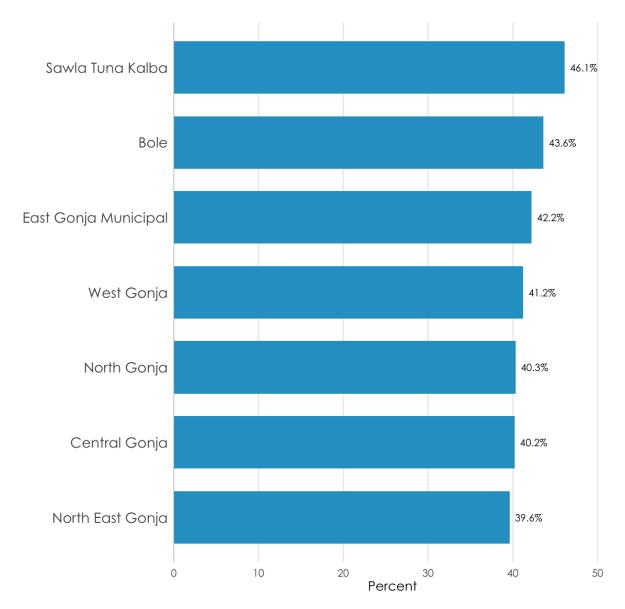

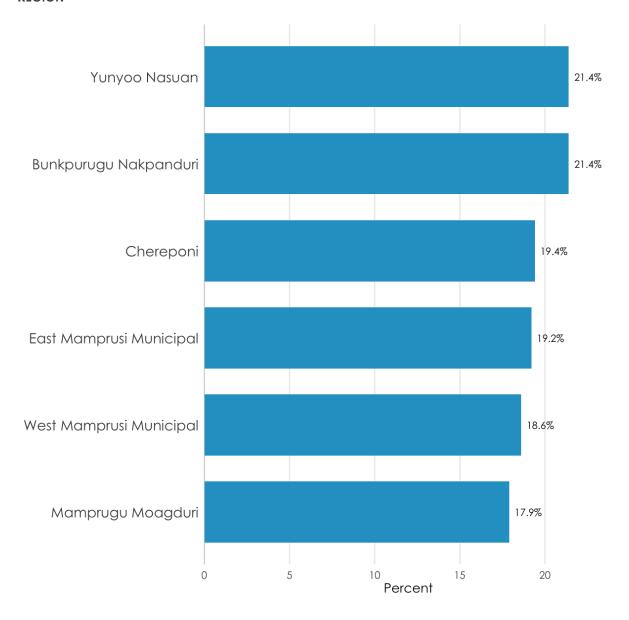

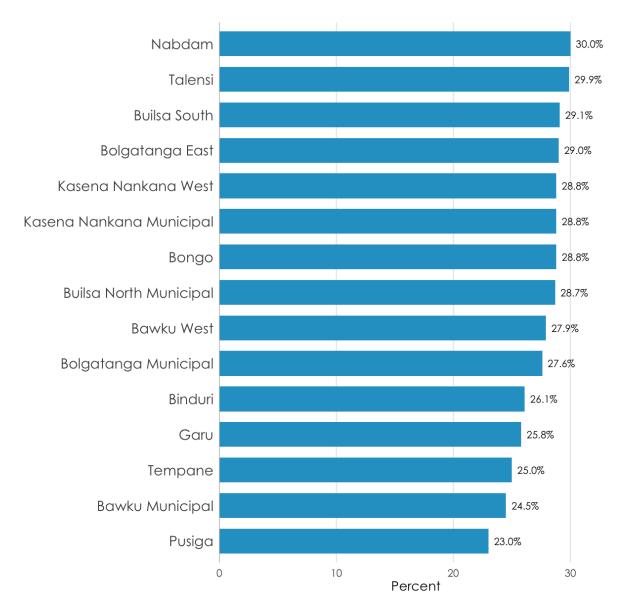

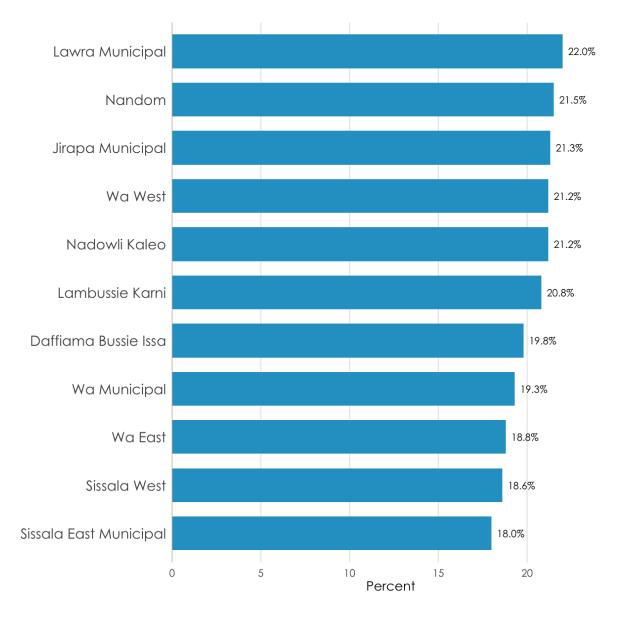

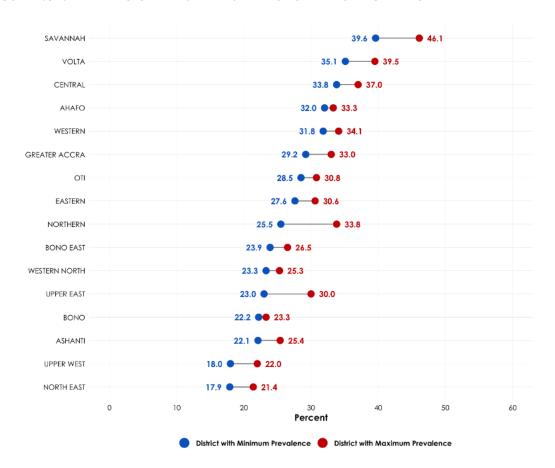

FIGURE 4.57: INTRA-REGIONAL DISPARITIES IN EMOTIONAL VIOLENCE AT HOME

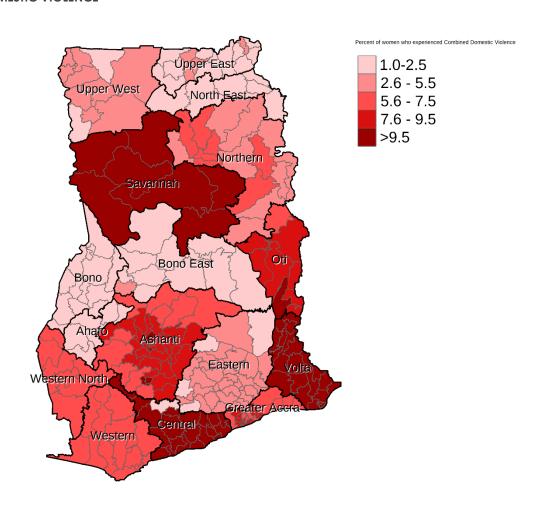

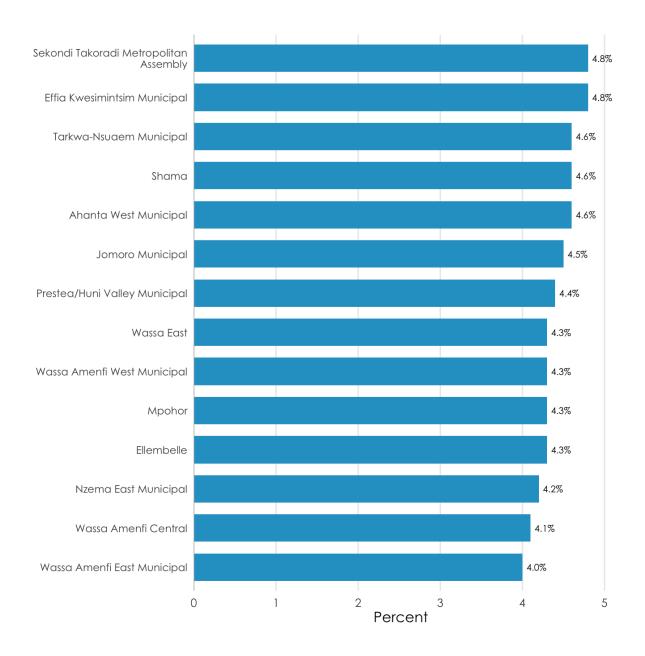

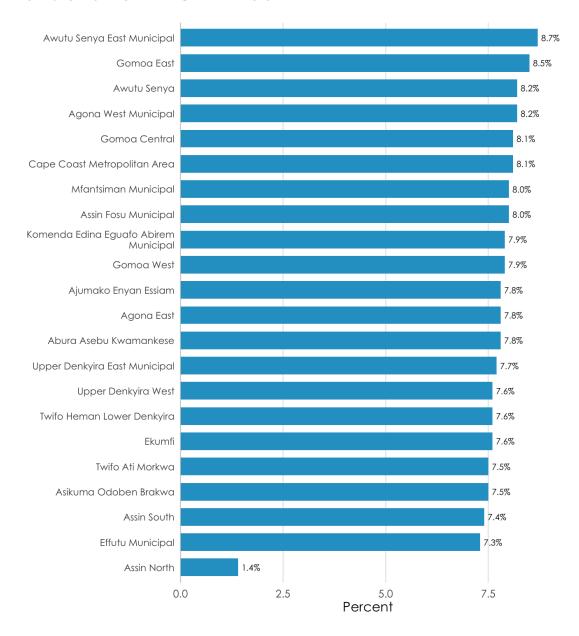

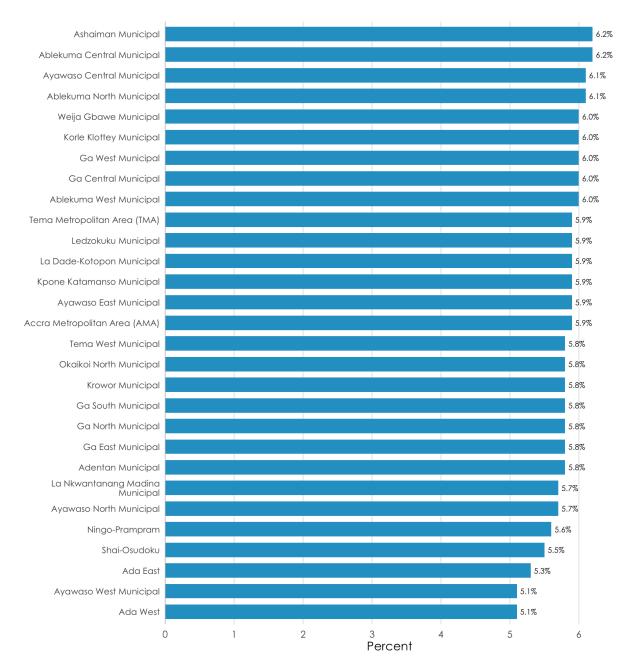

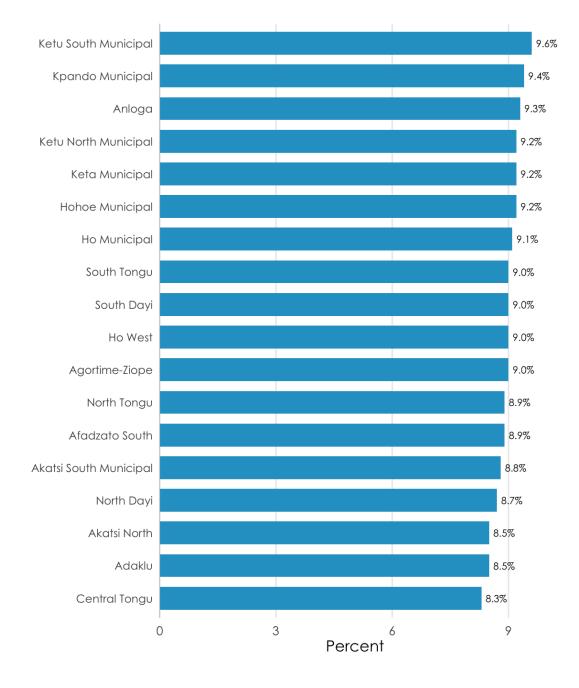

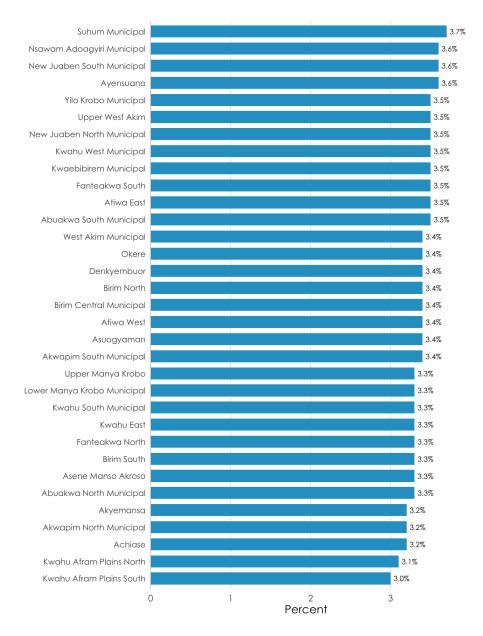

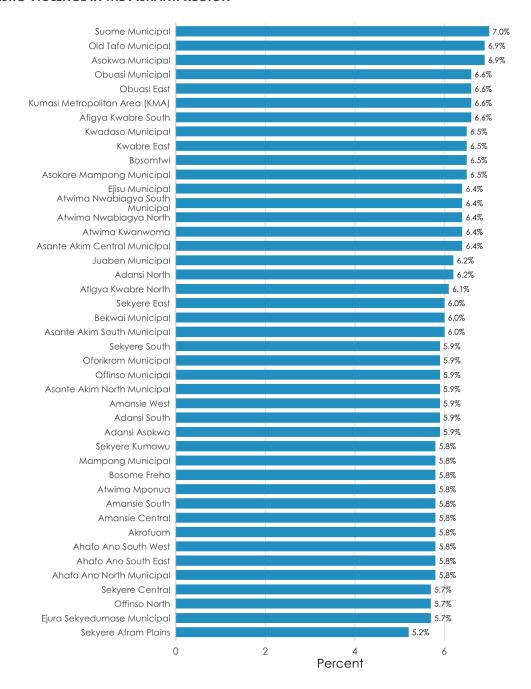

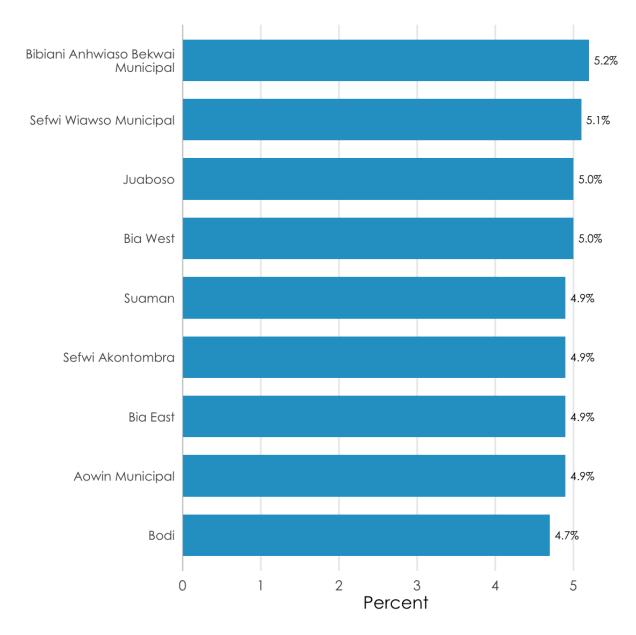

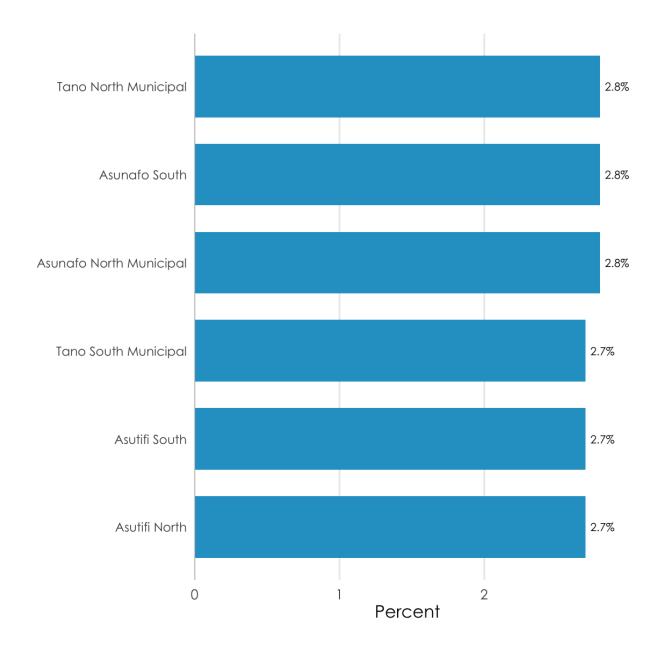

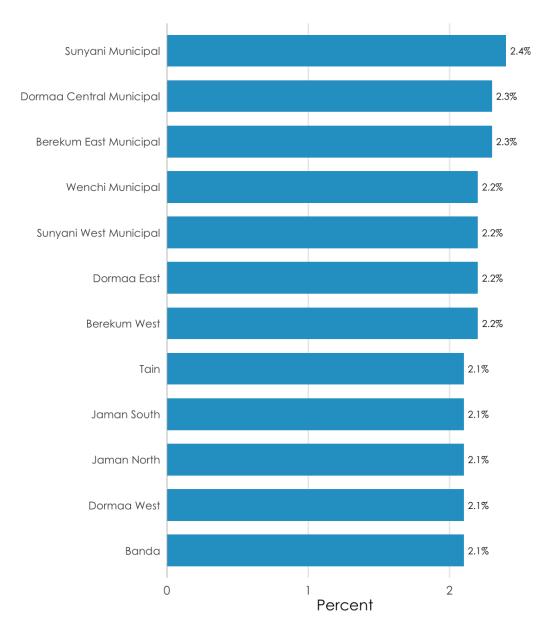

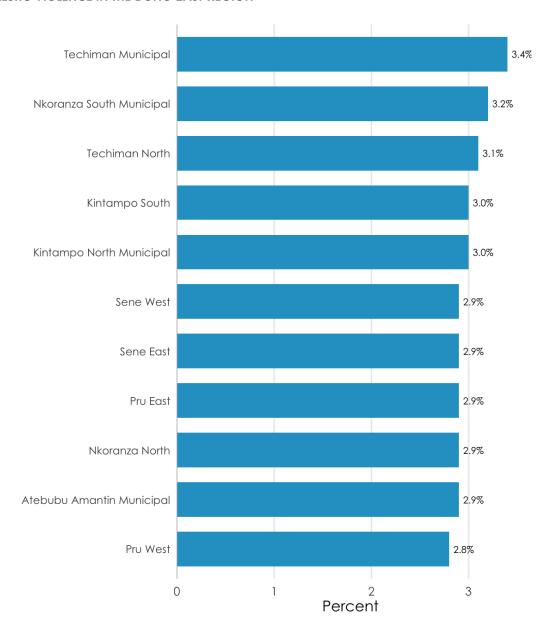
FIGURE 4.67: DISTRICT-LEVEL ESTIMATES OF WOMEN EXPERIENCING PHYSICAL, SEXUAL AND EMOTIONAL DOMESTIC VIOLENCE IN THE BONO REGION

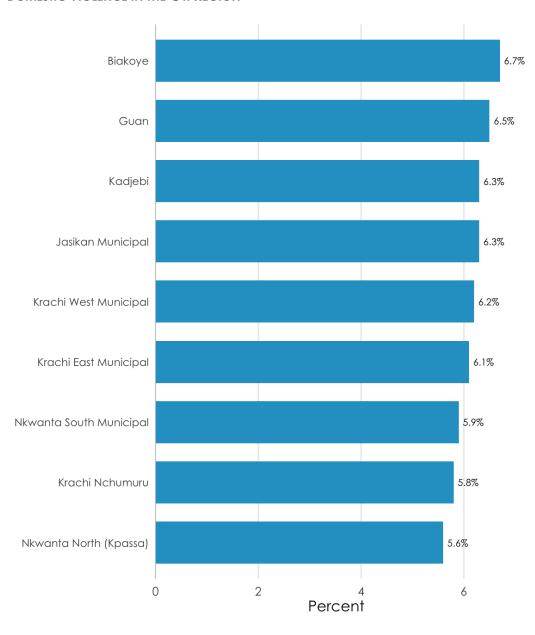
FIGURE 4.68.: DISTRICT-LEVEL ESTIMATES OF WOMEN EXPERIENCING PHYSICAL, SEXUAL AND EMOTIONAL DOMESTIC VIOLENCE IN THE BONO EAST REGION

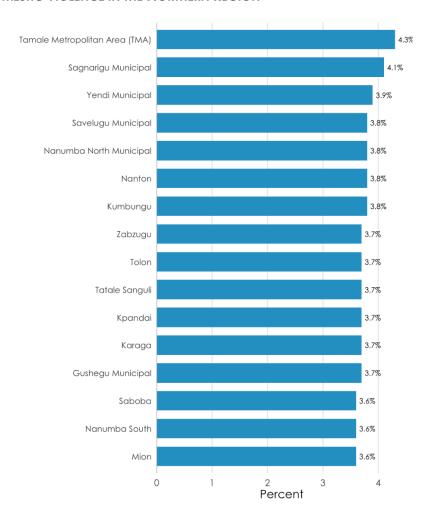
FIGURE 4.69: DISTRICT-LEVEL ESTIMATES OF WOMEN EXPERIENCING PHYSICAL, SEXUAL AND EMOTIONAL DOMESTIC VIOLENCE IN THE OTI REGION

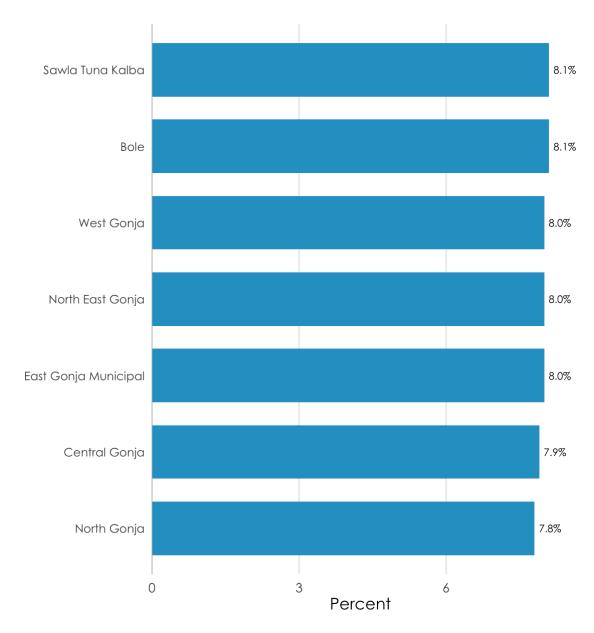
FIGURE 43.70: DISTRICT-LEVEL ESTIMATES OF WOMEN EXPERIENCING PHYSICAL, SEXUAL AND EMOTIONAL DOMESTIC VIOLENCE IN THE NORTHERN REGION



The rate of women experiencing all three forms of domestic violence in the Savannah Region is relatively high.

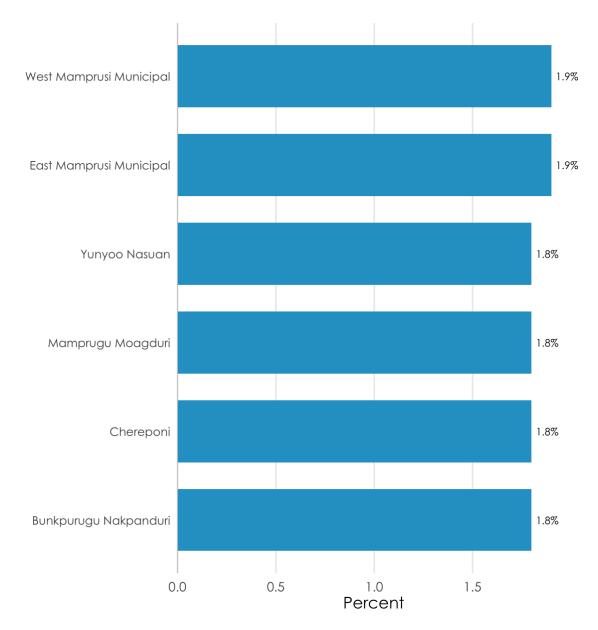

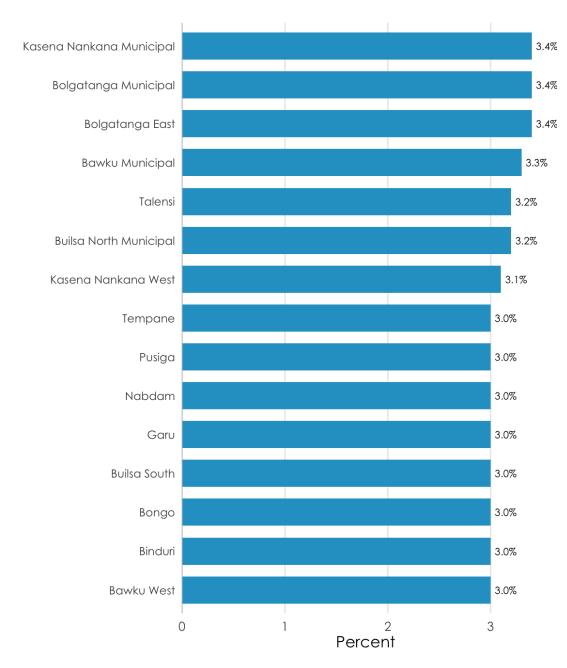

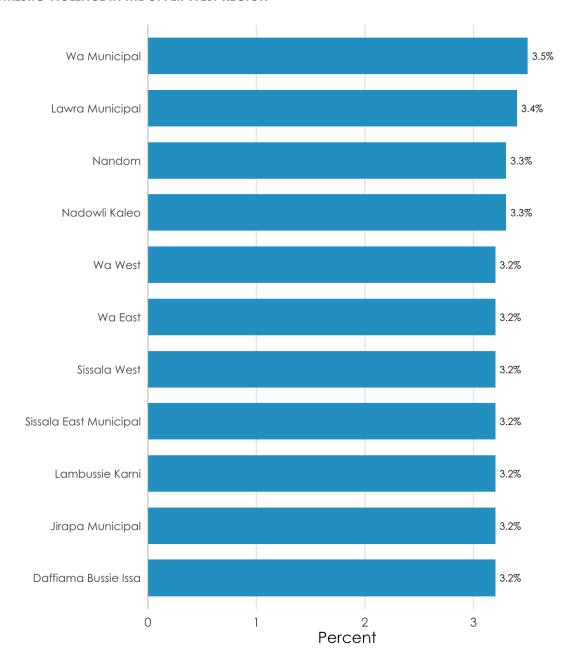
FIGURE 4.73: DISTRICT-LEVEL ESTIMATES OF WOMEN EXPERIENCING PHYSICAL, SEXUAL AND EMOTIONAL DOMESTIC VIOLENCE IN THE UPPER EAST REGION

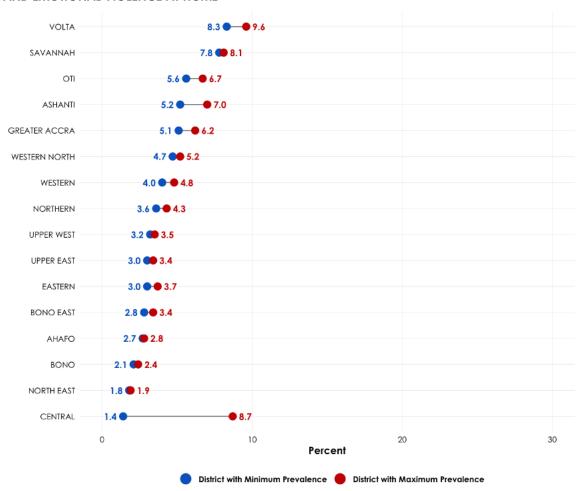

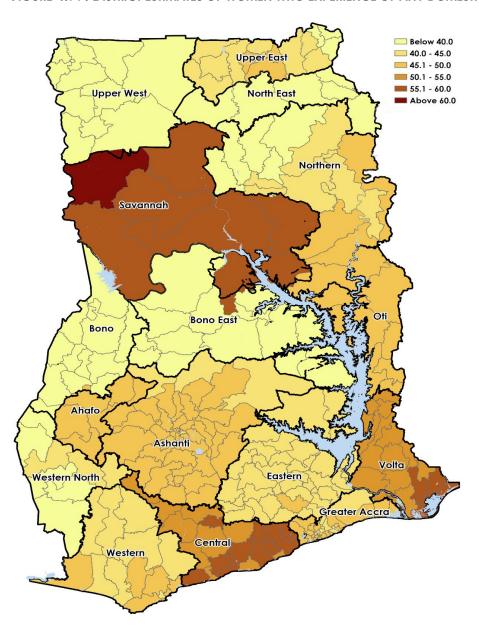


4.5 Either Physical, Sexual or Emotional Domestic Violence

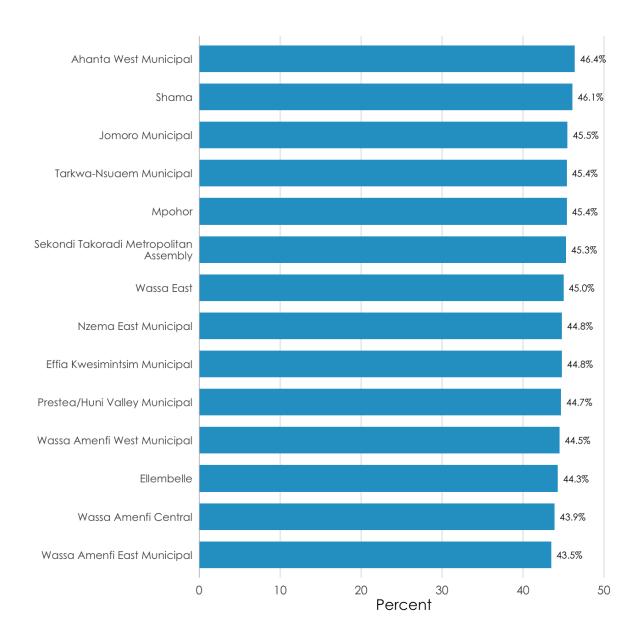
Domestic violence among women is largely prevalent across districts in the Savannah, Central, and Volta Regions, with rates ranging from 35.6 percent to 45.5 percent.

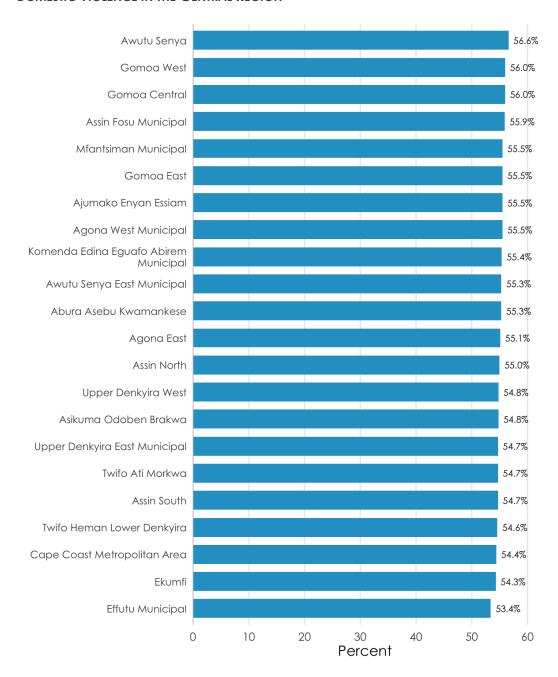

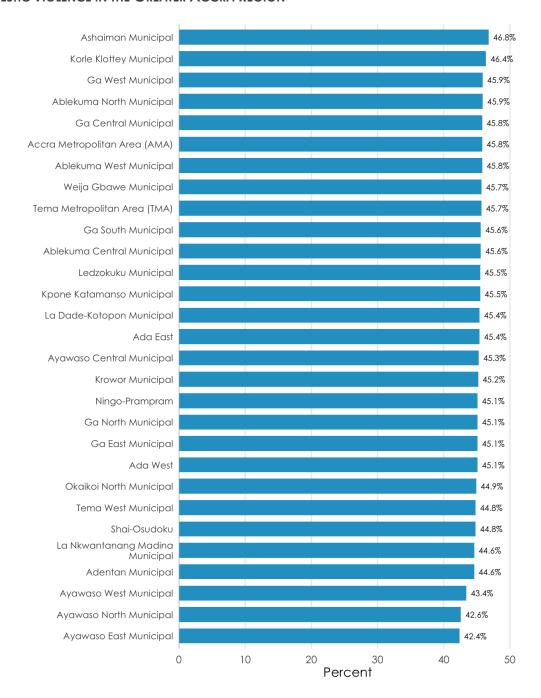
FIGURE 4.79: DISTRICT-LEVEL ESTIMATES OF WOMEN WHO EXPERIENCE ANY OF THE THREE FORMS OF DOMESTIC VIOLENCE IN THE CENTRAL REGION

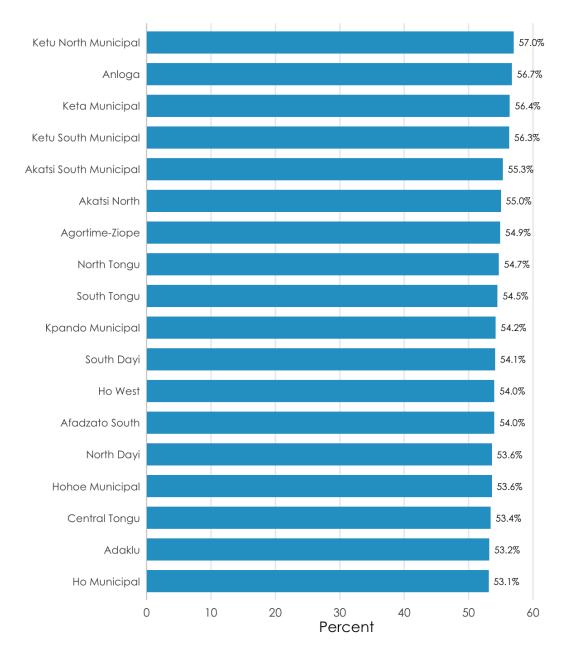

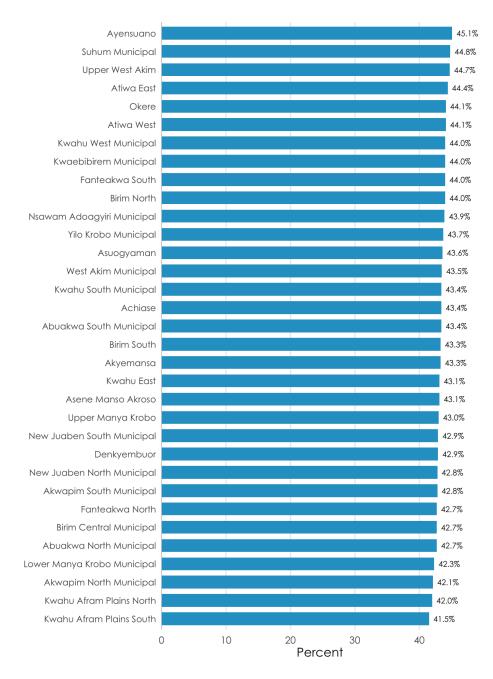

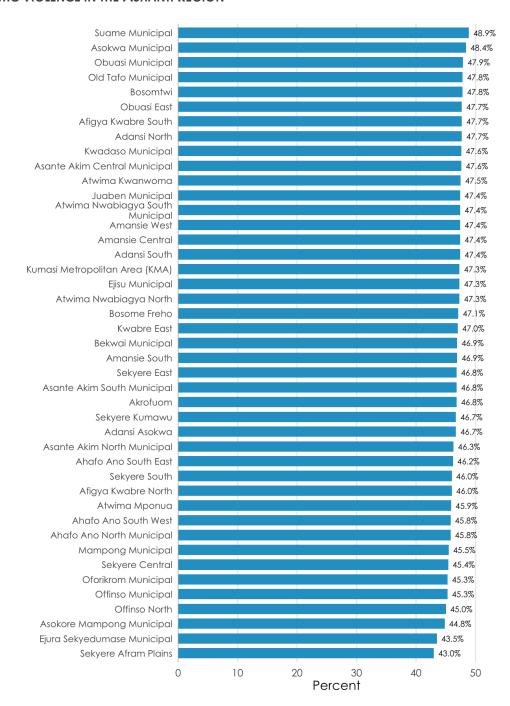
FIGURE 4.82: DISTRICT-LEVEL ESTIMATES OF WOMEN WHO EXPERIENCE ANY OF THE THREE FORMS OF DOMESTIC VIOLENCE IN THE EASTERN REGION

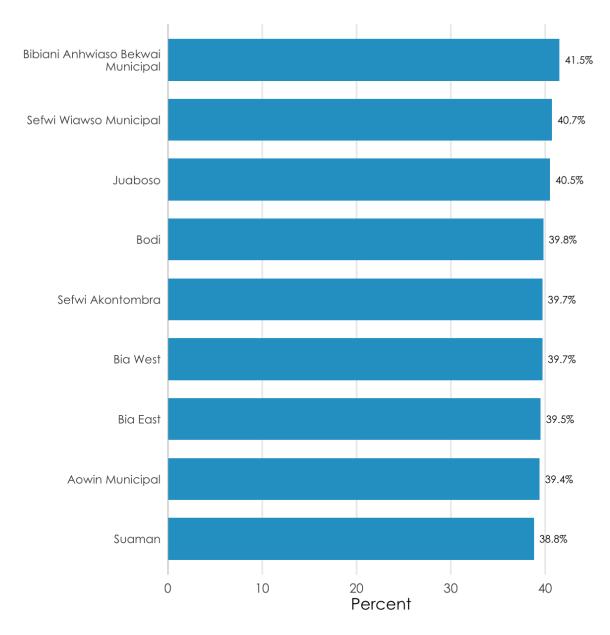

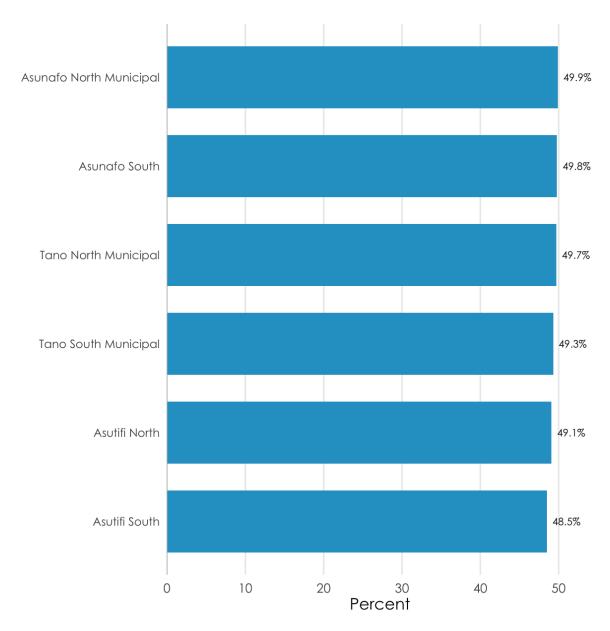

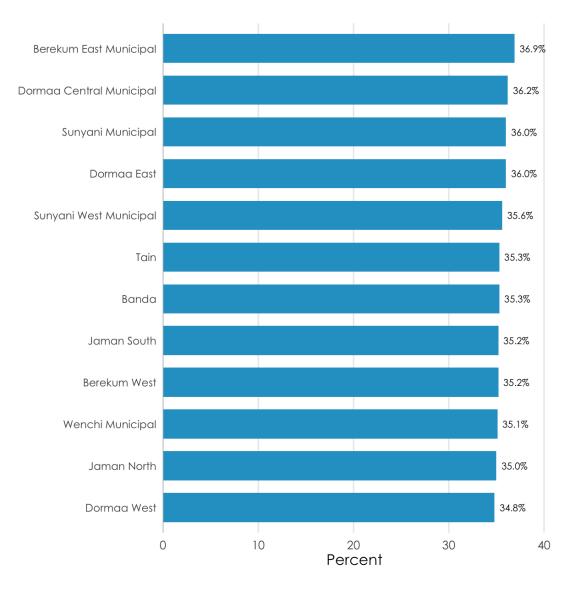

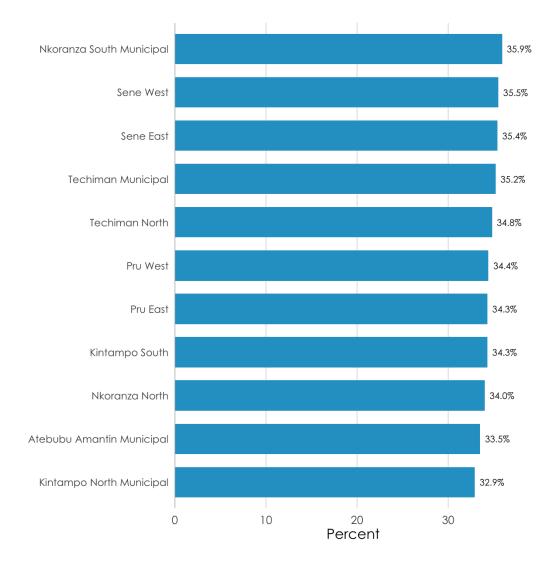

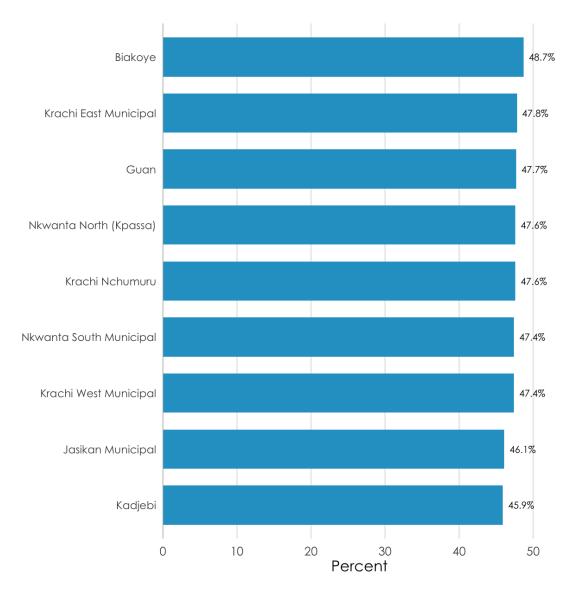

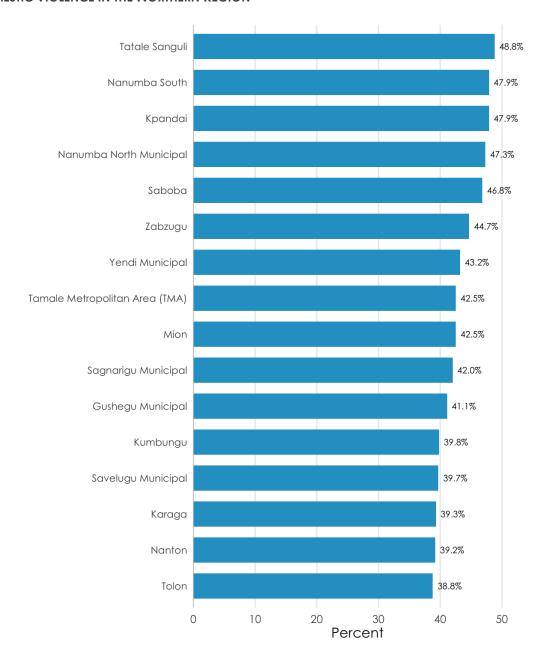

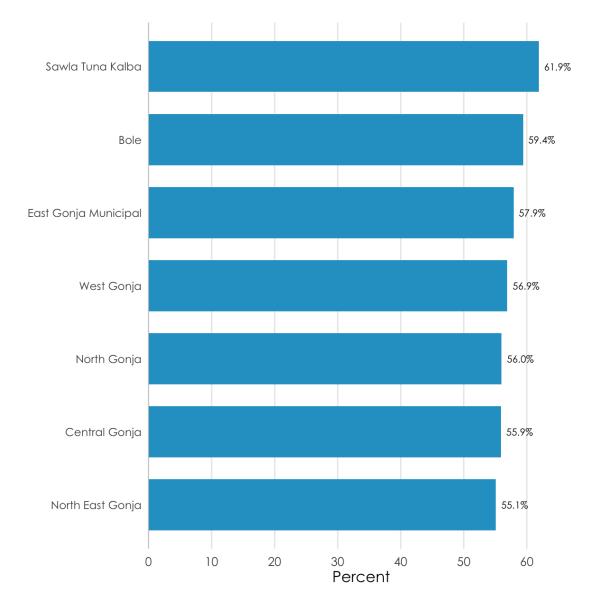

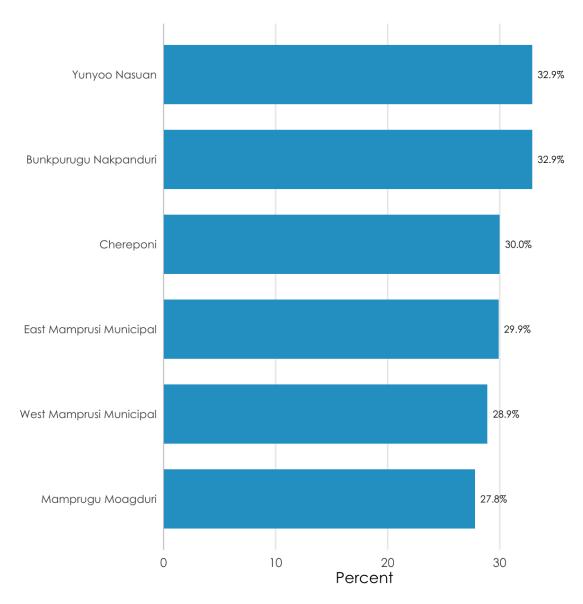

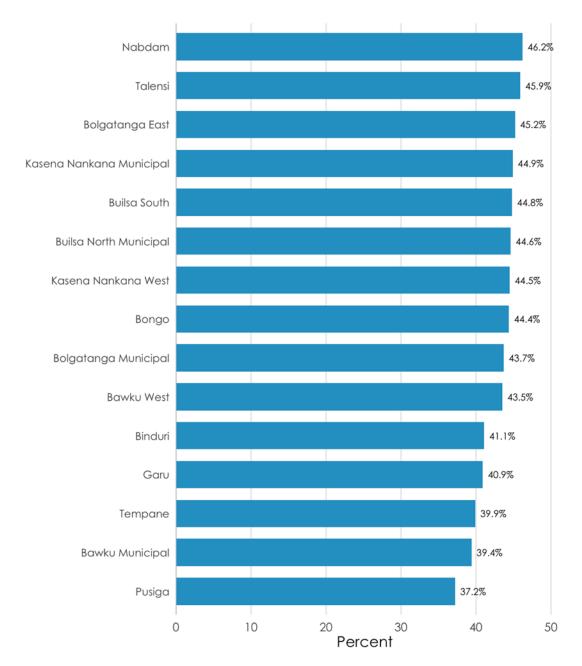

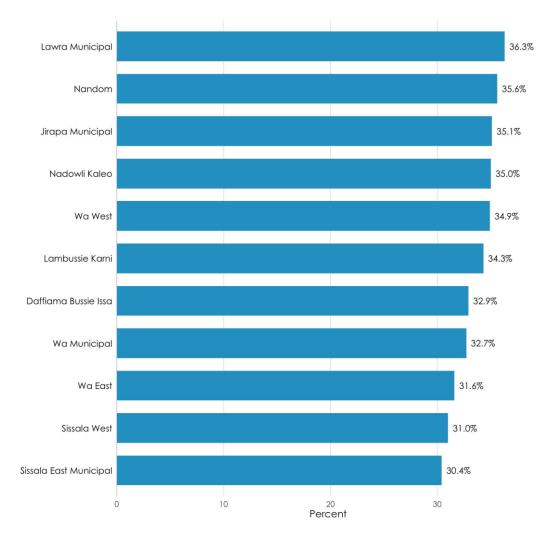

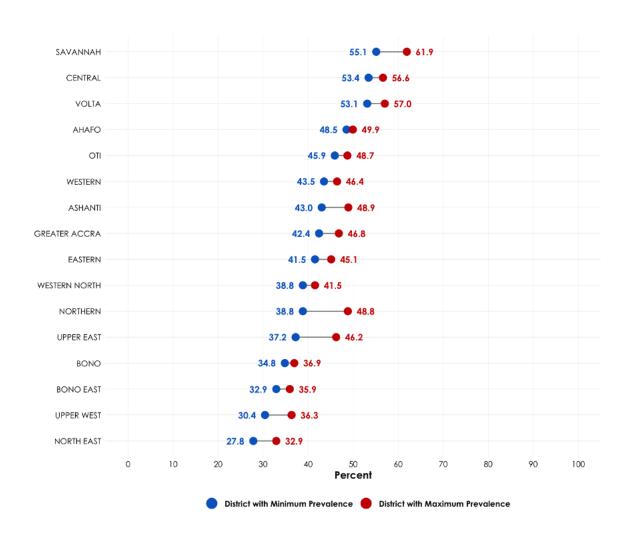

5. CONCLUSION AND POLICY RECOMMENDATIONS

5.1 Conclusion

The evidence shows that gender-based domestic violence in Ghana remains a serious and unevenly distributed problem. Districts in the Savannah, Volta, and Central regions record the highest rates of physical, sexual, and emotional abuse, while significant pockets of lower prevalence exist in Upper West, North East, Bono, and Bono East. The disparities are not random, they reflect differences in local norms, economic pressures, partner characteristics, and institutional capacity.

Small Area Estimation offers a more precise understanding of how these patterns play out across the country. It reveals that some districts face levels of violence far above their regional averages, demonstrating why national or regional data alone cannot guide effective intervention. Domestic violence undermines women's health, economic security, and social participation, and its effects ripple across generations. Addressing it must therefore be a priority for Ghana's development agenda.

Ending domestic violence requires targeted, district-specific action that combines prevention, protection, prosecution, and partnerships. This brief provides the evidence base needed to design and implement those strategies.

5.2 Policy Recommendations

Government

- Strengthen enforcement of national laws: Increase funding and personnel for DOVVSU, family courts, and gender desks. Ensure survivor-centred, timely justice across all districts.
- 2. **Deploy targeted interventions to high-prevalence districts**: Invest more heavily in the districts in Central, Volta, and Savannah with physical and emotional violence above 40 percent.
- 3. **Expand protection systems:** Scale up shelters, hotlines, legal aid, and psychosocial services, ensuring availability in rural and remote districts.
- 4. **Strengthen district assemblies' role**: Position district assemblies as the coordinating hubs for domestic-violence response, linking health, justice, social welfare, and community actors.

Civil Society & Development Partners

- 1. **Drive behaviour change through community engagement**: Support campaigns that challenge harmful norms, increase awareness, and encourage reporting, especially in high-risk districts.
- 2. **Support survivor rehabilitation**: Provide skills training, livelihoods support, mentalhealth services, and longer-term reintegration pathways.

Data & Policy Institutions

- 1. **Institutionalise district-level monitoring**: Integrate SAE estimates into national gender policies, social-protection strategies, and district planning processes.
- 2. **Strengthen data systems:** Improve administrative data quality, link survey and census information, and expand the routine collection of district-level violence data.
