Summary

The Index of Industrial Production (IIP) measures changes over time in production volumes for the industry sector. Annual and quarterly changes in the IIP levels measure the growth in production within the industry sector and its sub-sectors over the respective periods. This release uses 2021 as the reference period for computing the index. The publication highlights the annual (year-on-year) and quarterly (quarter-on-quarter) production growth rates for the following industry sub-sectors: mining and quarrying, manufacturing, electricity and gas, and water supply, sewage, and waste management.

The Year-on-Year (Y-o-Y) change in the IIP for 2025 Q1 is 2.9 percent. This means that, on average, production in the industry sector grew by 2.9 percent in 2025Q1 compared to 2024 Q1. The sub-sector changes are as follows:

- Manufacturing grew by 5.6 percent in 2025 Q1
- Mining and quarrying grew by 0.4 percent in 2025 Q1.
- Electricity and Gas grew by 10.5 percent in 2025 Q1.
- Water Supply, Sewage, and Waste management declined by 3.9 percent in 2025 Q1.

The Quarter-on-Quarter (Q-o-Q) change in IIP for 2024 Q4 is 1.7 percent. This means that, on average, production in the industry sector grew by 1.7 percent in 2025 Q1 as compared to 2024 Q4.

Figure 1: Trend in IIP by Sub-Sector

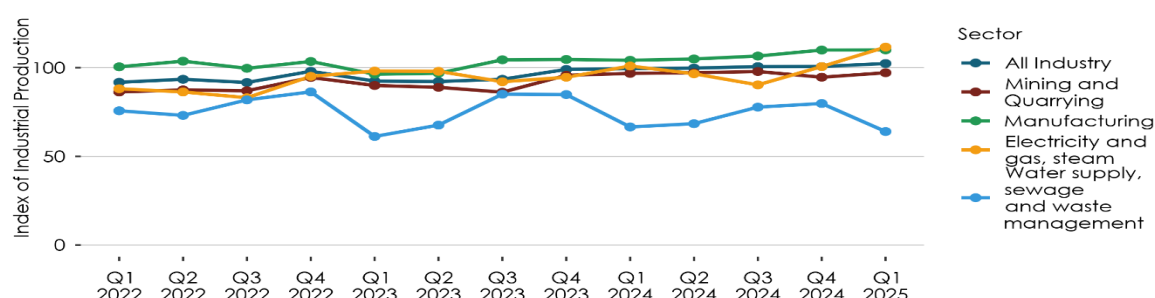

Mining and Quarrying Sub-sector

The Y-o-Y change in IIP for the Mining and quarrying sub-sector is 0.4 percent. This means that, on average, production in the Mining and quarrying sub-sector increased by 0.4 percent in Q1 of 2025 compared to Q1 of 2024.

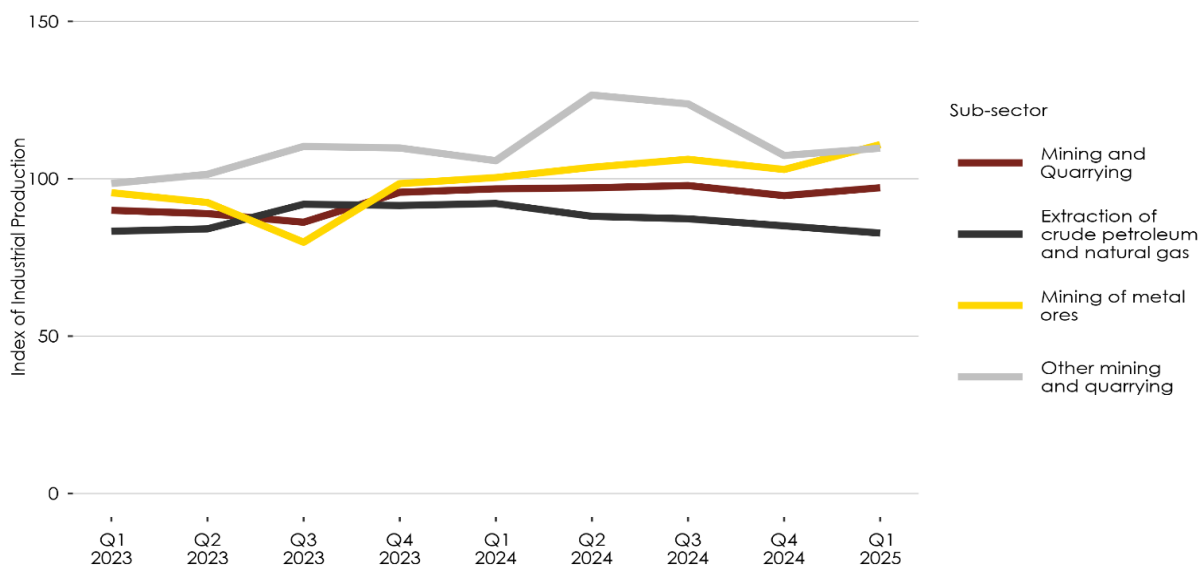
The Q-Q change in the IIP for this sub-sector is 2.7 percent. This means that, on average, production in the mining and quarrying sub-sector increased by 2.7 percent in Q1 of 2025 compared to Q4 of 2024.

Manufacturing Sub-sector

The Y-o-Y change in the IIP for Manufacturing is 5.6 percent. Thus, production levels in the manufacturing sub-sector, on average, grew by 5.6 percent in Q1 of 2025 compared to Q1 of 2024.

- Manufacture of other transport equipment recorded the highest growth (38.2%), while the manufacture of motor vehicles, trailers and semi-trailers declined by 27.8 percent.

The Q-o-Q change in IIP is 0.1 percent, indicating that on average, production in the manufacturing sub-sector grew by 0.1 percent in Q1 of 2025 compared to Q4 of 2024.

- The manufacture of other transport equipment has the highest Q-o-Q growth in production volume (25.4%).

Electricity and Gas Sub-sector

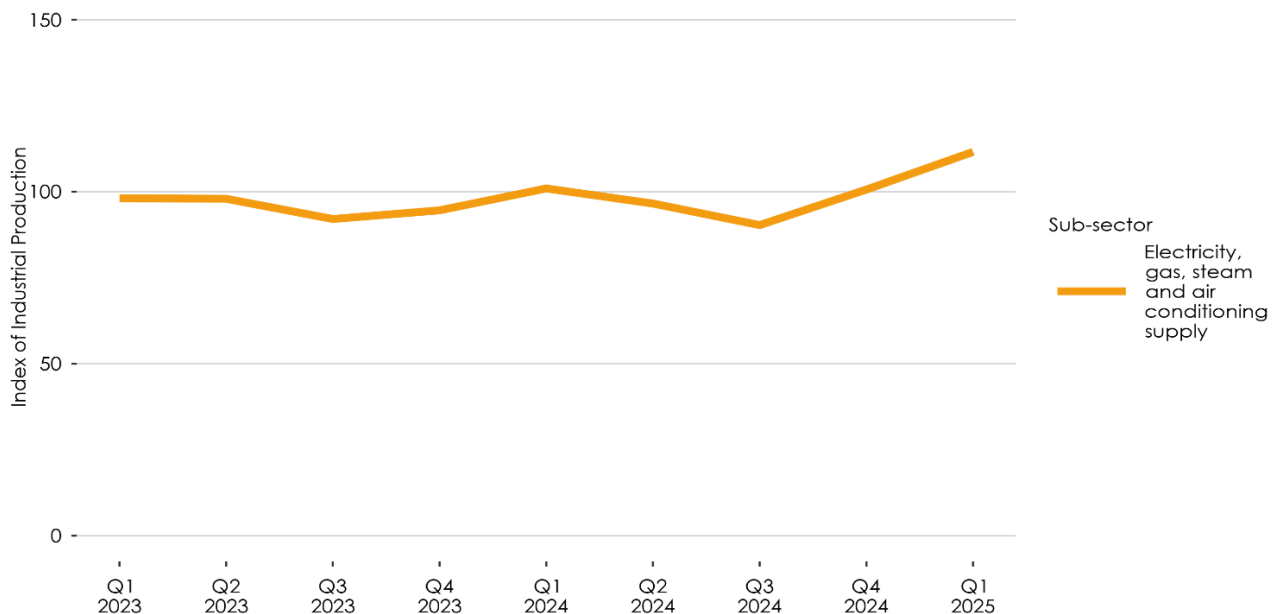
The Y-o-Y change in the IIP for Electricity and Gas is 10.5%. Thus, production for this sub-sector grew by 10.5 percent in Q1 of 2025 compared to Q1 of 2024

The Q-o-Q change in the IIP for this sector is 10.9 percent. This means that, on average, production in the Electricity and gas sub-sector grew by 10.9 percent in Q1 of 2025 compared to Q4 of 2024

Water Supply, Sewerage and Waste Management Sub-sector

The Y-o-Y change in the IIP for the Water Supply, Sewage, and Waste Management is -3.9%. Thus, production in the Water Supply, Sewage, and Waste Management sub-sector, on average, declined by 3.9 percent in Q1 of 2025 as compared to Q1 of 2024.

The Q-o-Q change in the IIP for this sub-sector is -18.9 %. Thus, relative to Q4 of 2024, the IIP in this sub-sector declined by -18.9 percent in Q1 of 2025.
